SPEAKER MARVEL: Would the committee please escort the Governor and his wife from the Chamber. The Legislature will come to order. There is some business on the Clerk's desk that we need to listen to before we recess this morning. Okay, Pat.

SPEAKER MARVEL: Record.

CLERK: There is a quorum present, Mr. President.

SPEAKER MARVEL: Item number three.

CLERK: Mr. President, your committee on Appropriations whose chairman is Senator Warner reports LB 157 on General File and LB 334 to General File with amendments, (Signed) Senator Warner. (See pages 987-988 of the Journal.)

Mr. President, I have an Attorney General's opinion addressed to Senator Kilgarin regarding LB 355. (See pages 988-990.)

Mr. President, two new resolutions, LR 41 by Senator Carsten. (Read.) Mr. President, that will be laid over. LR 42 offered by Senator Clark. (Read.) (See pages 990-991 of the Journal.) That will be laid over as well, Mr. President.

Mr. President, finally, Senator Howard Peterson would like to be excused tomorrow and Monday and Tuesday of next week.

SPEAKER MARVEL: Okay are we all ready now? Ready for item number four?

CLERK: Yes, sir.

SPEAKER MARVEL: We are ready for item number four, General File, priority bills.

CLERK: Mr. President, LB 17 was a bill introduced by Senator Jerry Koch and Senator Cal Carsten. (Read.) The bill was first read on January 8 of this year, Mr. President. It was referred to the Revenue Committee for a public hearing. The bill was advanced to General File. I do have committee amendments pending by Senator Carsten's Revenue Committee.

SENATOR WIITALA: That is right.

SENATOR NICHOL: Okay, thank you.

SENATOR CLARK: Senator Kahle.

Mr. President, LB 157 was a bill introduced by Senator Marvel at the request of the Governor and Senators DeCamp, Hefner, VonMinden, Wagner, Fitzgerald, Chronister and Wesely. (Read.) The bill was first read on January 14. It was referred to the Appropriations Committee. The bill was advanced to General File. I have no amendments on the bill, Mr. President.

SENATOR CLARK: Senator Marvel.

SPEAKER MARVEL: Mr. President, I move the advancement of the bill. Do you want me to explain it?

SENATOR CLARK: Explain the bill, please.

SPEAKER MARVEL: Okay. The Nebraska veterans' aid fund briefly is benefits in reverse most states as soon as veterans get home, give them a certain lump sum. Nebraska does not operate this way. What Nebraska does is to put money into the fund tied to a veterans aid fund in Nebraska and when there is a need, then that need is met. For instance this last year the average grant was \$250.46 and the process, in effect, goes from the American Legion Post, the V.F.W. Post, the D.A.V. chapters and the need is channeled through those organizations and the income from the money that is in the veterans' aid fund is used to pay for those in need. What this bill does is to change the statutory face value of Nebraska veterans' aid fund from \$11 million to \$11 million 500 thousand dollars and it is my understanding that next year if we proceed as we have in the past there will be added another half a million dollars. That is my explanation, Mr. President.

SENATOR CLARK: Senator Hefner.

SENATOR HEFNER: Mr. President, members of the body, I rise to support this bill, LB 157. This bill would increase the trust fund from 11 million dollars to 11 million 500 thousand dollars, an increase of a half a million dollars and I think this is a good way to help out our veterans and what they do is use the interest that this fund provides to take care of emergency situations and so, therefore, I would rise and urge you to support this measure.

SENATOR CLARK: Senator Koch.

SENATOR KOCH: Mr. Chairman, I move the previous question. We are all familiar with this bill.

SENATOR CLARK: The previous question has been called for. Do I see five hands? All those in favor of ceasing debate vote aye, those opposed nay. Have you all voted? Record the vote.

CLERK: 26 ayes, 0 mays to cease debate, Mr. President.

I think that the fact that we have discussed the bill should perhaps wipe out any reason for a lot of lengthy debate. I know there are a lot of other bills that you want to get to today. I just want to say in reply to a piece of material that is lying on your desk, two and a half pages in length, which casts serious doubts about the problems that LB 243 can cause, I want to say this. You will recall that Senator Kremer and myself and along with several...at least 23 others in this body successfully added about \$2 million to the water development fund. are rumors now that they may want to cut that back in the Executive Office to \$3 million from 4. That means that we will have about an additional \$800,000 in the water development fund, 50 cents per capita. Not exactly an overwhelming amount of public support I would guess for water development. My concern as I have indicated many times on this floor is this, if we are going to use funds that have been generated by a subdivision of government for
