SPEAKER MARVEL: Will you please record your presence? Record.

SPEAKER MARVEL: Underneath the North balcony, it is my privilege to present visitors to Nebraska sponsored by Partners of the Americas and the sponsors are Mrs. Ben Schulze and Gilbert Erickson and the visitors are coordinated with Dr. Fortes and his wife Maranna and the technical title is the Coordinator of Congressional Affairs for the Ministry of Education and Cultural Affairs from Brazil. Your Enrolling Clerk respectfully reports that she has on February 23 at 2:37 p.m. presented to the Governor the following bills: 31, 33, 85, 96 and 120.

Mr. President, your committee on Enrollment and Review respectfully reports we have carefully examined LB 24 and find the same correctly engrossed.

Your committee on Appropriations whose chairman is Senator Warner to whom is referred LB 158 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File with amendment, (Signed) Senator Warner, Chair.

Mr. President, I have a report from the State Employment and Training Council. It will be on file in my office.

Mr. President, Senator Cullan asks unanimous consent to add his name to LB 213 as cointroducer.

SPEAKER MARVEL: Do you have any other items?

CLERK: No. sir.

SPEAKER MARVEL: Okay, item #4, resolutions.

SPEAKER MARVEL: The bill is advanced.

SENATOR WESELY PRESIDING

SENATOR WESELY: Mr. Clerk, would you please read LB 158.

CLERK: Mr. President, LB L58 was offered by Senator Marvel at the request of the Governor. (Read.) The bill was read on January 14, referred to Appropriations. The bill was advanced to General File. There are committee amendments pending by the Appropriations Committee, Mr. President.

SENATOR WESELY: Senator Warner, do you wish to take the committee amendments?

SENATOR WARNER: Senator Marvel will take it. He has got it. I move their adoption. They are real good.

SENATOR WESELY: Senator Marvel, do you wish to take the committee amendments to LB 158?

SENATOR MARVEL: I have two sheets that back up the presentation and the first one is the introducer's statement of purpose which states, in effect, that this bill is to create a cash fund for the State Energy Office. This fund will be used to deposit energy audit fees collected from various state agencies. The fees will pay the cost of conducting energy audits of state owned buildings and reporting the results of the audits back to the agencies. The energy savings realized from the conservation measures recommended by each audit will save the state a substantial amount in energy costs. Now the Appropriations Committee has offered a series of amendments to LB 158. There are...the first one, the revolving fund instead of a cash fund; secondly, a two year life, twenty-seven months; third one, audits would be mandatory not voluntary; number four, cost of audit limited to actual cost of the audit not to exceed five cents per square foot; number five, reports of audits are to be submitted to the budget administrator and the legislative fiscal analyst within sixty days and this finally, Mr. President, is the impact of these amendments. The Energy Office could charge up to \$1,500 for a thirty thousand square foot building, \$2,000 for a forty thousand square foot building as opposed to the \$150 and \$200 estimate originally arrived at. The next impact, instead of spending \$73,603 maximum, the Energy Office fiscal note estimates expenditures of \$125,450 in '81-'82 and \$147,393 in '82-'83. The third impact is stated as follows: The staff reduction, the energy auditors could not take place and item number four, the energy office will be hard pressed to do all necessary audits in two years as they have revised their estimates from seventeen hundred

state buildings to thirty-five hundred to four thousand state owned buildings. Those constitute the background information that has been given to me, Mr. President. I renew my motion to advance the bill.

SENATOR WESELY: The question is the adoption of the committee amendments to LB 158. All those in favor vote aye, opposed nay. Clerk, record.

CLERK: 26 ayes, 0 mays, on adoption of committee amendments.

SENATOR WESELY: The amendments are adopted. The question now is the advancement of the bill, LB 158. No one to speak. Those in favor vote aye, those opposed nay.

SENATOR LANDIS: Mr. Speaker, members of the Legislature, the committee amendment is simply technical in nature in that we are only capable of regulating domestic insurance corporations since foreign insurance corporations are regulated by the states in which they are domiciled and for that reason the committee chose to interpolate the word "domestic" into the projected bill for the purpose of making it clear that is whom we intend to regulate by LB 330. We could do no other. It is just that this is making it explicit in statute that we intend this to apply only to domestic insurance corporations.

SPEAKER MARVEL: The motion is the adoption of the committee amendments as explained by Senator Landis. All those in favor vote aye, opposed vote no. Record the vote.
