roll call but we have to ha everybody in their seats first. Senator Wesely, for what purpose do you rise?

SENATOR WESELY: Point of information, please. I was wondering if the Clerk would one last time explain the vote we are taking at this point.

SPEAKER MARVEL: Can we just simply read the motion? Is there a motion?

SENATOR WESELY: If that is sufficient, that would be fine.

CLERK: Mr. President, the motion pending before the body is to adopt the remaining permanent rules for the 87th Legislature, First Session, as now currently in our possession.

SPEAKER MARVEL: Roll call has been requested. Clerk will call the roll.

CLERK: (Roll call vote taken as found on page 174 of the Legislative Journal). 15 ayes, 27 nays, Mr. President.

SPEAKER MARVEL: Motion lost. The Call is raised. Senator Wesely, for what purpose do you rise?

SENATOR WESELY: If I could have an opportunity to explain the situation as it stands right now, Mr. Speaker, so they would understand where we stand with the rules. Would that be possible?

SPEAKER MARVEL: The Chair is going to make a suggestion. We are going to be facing this kind of procedure from now on and the Chair would like to meet with Senator Chambers. The Chair would like to meet in the Speaker's office with Senator Chambers, Senator Beutler, Senator Kremer and Senator Goodrich immediately upon adjournment and see if we can settle this without taking all this extra time. Now what is before the House? Okay, the Clerk has some items to read in. I would like to meet with Senator Chambers, Beutler, Kremer and Goodrich as soon as we adjourn.

CLERK: Mr. President, your committee on Public Works gives notice of hearing in Room 1517. Your Committee on Education gives notice of public hearing in Room 1517.

Mr. President, a second notice from the committee on Eduation regarding scheduling of public hearings.

Mr. President, new bills. (Read LB 188A; LB 234 A. See page 478 of the Legislative Journal.)

Mr. President, I have an Attorney General's opinion addressed to Senator Maresh regarding LB 518 from the 1977 legislative session.

Senator Burrows would like to have amendments printed in the Legislative Journal. (See page 479 regarding amendments to LB 167.)

I have notice of hearing from the Public Works Committee.

Mr. President, your committee on Ag and Environment whose chairman is Senator Schmit to whom is referred LB 80 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; 104 General File with amendments; 236 General File with amendments, (Signed) Senator Schmit. (See page 480 of the Journal.)

Your committee on Government, Military and Veterans Affairs whose chairman is Senator Kahle to whom is referred LB 221 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; 21 General File with amendments; 186 General File with amendments, (Signed) Senator Kahle. (See page 481 of the Journal.)

Mr. President, your committee on Miscellaneous Subjects whose chairman is Senator Hefner to whom is referred LB 124 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; 206 General File; 67 General File with amendments; 77 General File with amendments.

PRESIDENT: Any further discussion on LB 21? Senator Lamb, do you wish to close? No closing, so the question is the advance of LB 21 to E & R Initial. All those in favor vote aye, opposed may. Record the vote.

CLERK: 35 ayes, 0 mays on the motion to advance the bill, Mr. President.

PRESIDENT: The motion carries and LB 21 is advanced to E & R Initial. The next bill on General File is LB 186, Mr. Clerk.

CLERK: Mr. President, LB 186 was offered by Senator Emil Beyer. (Read title.) The bill was read on January 14, referred to the Government, Military and Veterans Affairs Committee for public hearing. The bill was advanced to General File. There are committee amendments pending by the Government Committee, Mr. President.

PRESIDENT: The Chair recognizes Senator Kahle.

SENATOR KAHLE: Mr. President and members, LB 186 has to do with the uniforms worn by peace officers, and at the hearing we had a number of peace officers present. We thought it would be advantageous to look at this bill and I am sure Senator Beyer will tell you more about it. The only amendment that we added is on page 3, line 12 in the bill where it says, brown in color insert "in the same color as the leather worn". This is really an insignificant ameniment but I am sure that our peace officers want to be dressed as sharp as they can and the leather they wear should match. So the amendment is only to change that part of it or to allow the fact that the leather they wear, the belt, the shoes, their holster, whatever else they might have would match. I move the amendment to LB 186.

PRESIDENT: Senator, is that the committee amendment or is that your amendment?

SENATOR KAHLE: That is the committee amendment.

PRESIDENT: All right. You said that the committee amendment is...(interruption).

SENATOR KAHLE: Oh, okay....I beg your pardon, they say it's my amendment.

PRESIDENT: Okay, yes, we wish...would you address the committee amendment at this point?

SENATOR KAHLE: Okay.

PRESIDENT: All right, so if you would take up the committee amendment because that is what is before the House.

SENATOR KAHLE: Well, the committee removes the reference that the Department of Administrative Services purchase the uniforms for the sheriffs and the deputies. Also deleted is the requirement that counties purchase the uniforms from DAS. The result is that DAS picks up the supplier or suppliers of the uniforms....picks the suppliers and the supplier of the uniforms with the state not having to pay out any money for the uniforms. By deleting reference to the counties purchasing the uniforms, how they are paid for is left to the negotiation between the sheriff's department and the counties. didn't want to obligate the counties or those cities that have peace officers that would want to participate in this to buying the uniforms. Some counties do buy the uniforms or at least pay part of the uniform, most of them do, some do not. The amendment would just state that the uniforms are available and that they should be purchased and be alike. I think this is only sensible. We think it would save the subdivisions of government that have these law enforcement officers on their payroll, either save them or the officer themselves considerable money if they could buy the uniforms wholesale from a given supplier. I think that pretty well explains the committee amendment. We are not obligating the counties or the cities to buy the uniforms for the officers. That is up to them. I move the committee amendments.

PRESIDENT: Any further discussion on the committee amendment? The question then is the adoption of the committee amendment on LB 186. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 32 ayes, 0 nays, Mr. President, on adoption of the committee amendments.

PRESIDENT: The motion carries. The committee ameridments are adopted. All right, we will go to the explanation of the bill, Senator Kahle, and then come back to your amendment. So now, Senator Beyer, would you make an explanation of the bill at this point. The Chair recognizes Senator Beyer.

SENATOR BEYER: I think Senator Kahle did a pretty good job of explaining it, especially the amendment part, and

my light isn't working, Mr. President. Mr. President and fellow committee members, or fellow legislators, this bill is something that I believed in when I introduced it on behalf of the Sheriffs and Peace Officers Association. I think we need some uniformity throughout the state in the sheriffs' department, but the big advantage that was addressed and that come down in the amendment was the fact that there will be a central purchasing point that the deputies or the counties, whichever way it is in there, can go to, and it will be quite a saving either to the deputies or to the county in the long run. So this is my reasoning for it and I support the amendments that were proposed before. Thank you.

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Senator Kahle, your amendment is up there. The Clerk will....(interruption).

SENATOR KAHLE: Okay, I will just briefly state, Mr. Speaker, the amendment just coordinates their outfits. If they wear brown shoes and brown belt and a brown holster, why it is only natural that all the accessories that are called leather would be the same. This was left out of the specifications for the uniform. I think it would only help make them look sharp and that was the intent. I move the adoption of the amendment.

SPEAKER MARVEL: Seeing no lights, I will put the question, all those in favor....Senator Cope, your light is on.

SENATOR COPE: Mr. President and members, I am not sure this is the place for the question but I do need to ask a question before the bill moves. Can I ask it now?

SPEAKER MARVEL: Go ahead.

SENATOR COPE: I have a question of Senator Beyer. Senator Beyer, I just want to be sure now, how is the state involved? Do they buy the uniforms and resell them or do they just recommend the type of uniform and the uniforms are bought through the counties?

SENATOR BEYER: Senator Cope, with the amendment that was just adopted prior to this, the Department of Administrative Service puts out this description for bids, then those bids are put in. The Department of Administrative Service does not buy these uniforms. It is the contract that they sign that all the sheriffs' departments will go to that supplier to get their uniforms. It takes out the

fiscal impact that is shown in the bill. This amendment was in agreement with the counties, the sheriffs' department and the Department of Administrative Services. It does not force them to buy it, only get the contract from the suppliers.

SENATOR COPE: That answered my second question, the fiscal impact, so, fine. Thank you.

SPEAKER MARVEL: The motion is the Kahle amendment to LB 186. All those in favor of that amendment vote aye, opposed vote no. Have you all voted? Record.

CLERK: 27 ayes, 0 mays on adoption of Senator Kahle's amendment, Mr. President.

SPEAKER MARVEL: The motion is carried. The Kahle amendment is adopted. Do you have anything else on the bill?

CLERK: Yes, sir. Mr. President, Senator Wesely now moves to amend the bill. (Read the Wesely amendment.) That is offered by Senator Wesely.

SPEAKER MARVEL: Senator Wesely, do you wish to be recognized?

SENATOR WESELY: Yes. Mr. Speaker and members of the Legislature, this is a technical amendment to the bill. There is some concern about what exactly we mean by the term "pink tan". This attempts to clarify that by striking the "tan" and leaving the "pink". This is an amendment which was provided last year when this bill came up by Senator Cullan who I am surprised isn't here today because he was equally concerned about this issue and had the same amendment so, in deference to the Chairman of the Public Health Committee and in an effort to clarify this legislation, I thought I would offer this amendment in hopes to clear up what exactly the color is we are talking about for the trousers and the skirts and the neckties.

SPEAKER MARVEL: Senator Kahle, do you wish to be recognized?

SENATOR KAHLE: Well, I don't remember, Mr. Speaker, the argument we had last year, but I really believe that "pink tan" represents the color better than passion pink might, for instance, and I believe that is the specific color that those ties are called. So I really don't see anything wrong with that language, but if you want to

change it to pink I really have no objection but I don't believe it does anything. "Pink tan" is a shade of tan rather than pink. Thank you.

SPEAKER MARVEL: Senator Goodrich.

SENATOR GOODRICH: Just one little point. Senator Wesely did a lot of talking but he didn't say what his amendment did. Where is Senator Wesely? Are you going to make all the guys wear pink trousers, or are you going to make them wear tan trousers? You talked but you didn't say which color you was picking.

SPEAKER MARVEL: Do you yield, Senator Wesely? Do you want to answer his question? Okay.

SENATOR WESELY: Although I would prefer tan I have discussed it on the floor and a number of Senators would prefer pink and so the amendment deletes tan and prefers pink.

SPEAKER MARVEL: Senator Marsh.

SENATOR MARSH: Mr. Speaker and members of the Legislature, doesn't it seem a little foolish to be fighting over colors? Is this something we really want in our statute? Could not the next year they decide they want to go to dove gray, or another color? Let's not limit them by putting in this kind of wording into the statutes.

SPEAKER MARVEL: The motion before the House is the Kahle amendment to LB 186. Senator Wesely, you withdrew your amendment, didn't you? Did he withdraw it? Did you withdraw your amendment? Is there any other amendments? Okay, we will...all those in favor of the Kahle amendment to LB 186...okay, the motion is to advance the bill as amended. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 26 ayes, 0 mays on the motion to advance the bill, Mr. President.

PRESIDENT: The motion is carried. The bill is advanced. The Clerk has some items to read in.

They do have a picture of the State of Nebraska with Douglas County outlined in dark blue. So my amendment would simply add and make (j) read "Badge bearing state or state seal, rank, and county:". This, at least, would bring the badges for the Deputy Sheriffs of Douglas County into conformance with the law or with this bill as it now stands and I urge that you adopt this amendment.

SPEAKER MARVEL: Any further discussion? The motion is the Pirsch amendment to LB 186. All those in favor of that motion vote aye, opposed no. Record the vote.

CLERK: 31 ayes, 1 may, Mr. President, on adoption of the Pirsch amendment.

Now what concerns me is what are we creating here with regards to liquor licenses. concept of public convenience and necessity I could perhaps

SENATOR KILGARIN: Mr. Speaker, I move the E & R amendments to LB 459.

SPEAKER MARVEL: All in favor of that motion say aye, opposed no. The motion is carried. The E & R amendment is adopted.

CLERK: Mr. President, I now have a motion from Senator Fowler. (Read Fowler amendment as found on page 733 of the Legislative Journal.)

SPEAKER MARVEL: The Chair recognizes Senator Fowler.

SENATOR FOWLER: Mr. President, this bill changes the contribution rates with regards to certain aspects of retirement. In working with the legislative fiscal staff we felt that rather than have the bill take effect on whatever day, ninety days after the session which may be in the middle of a pay period, that we would try and pick a date for it to take effect so as to ease implementation. The offices are for the knor, the Lieutenant Governor, Secretary of State, Actorie General, Auditor of Public Accounts and State Treasury.
