SENATOR GOODRICH: Mr. President, members of the body, this is the A bill that goes with the constitutional amendment, I am sorry, the bill that raises the salaries on constitutional officers and it calls for around \$5,700 this year and I would just move the advancement of the bill so we can get it over to Final Reading so when the bill itself is considered on Final Reading we have this one with it.

SENATOR CLARK: Is there any discussion on the bill? Senator Kahle.

The reason I would like to withdraw this bill is actually threefold. First of all, the Appropriations Committee has introduced a bill which will do the same exact thing and apply that money to the general fund. am opposed to that bill but I don't want to be misunderstood... I don't want my bill out thereso people misunderstand exactly what is happening. My bill is a bill that was originally introduced on behalf of the Tax Commissioner, Mr. Herrington, who is now gone. It was to do away with the general homestead per his recommendations. The cost amounts, the idea was to reduce the cost of administration to that program. I have asked the new Tax Commissioner if the cost amounts were all that great. He, basically, doesn't think so. He thinks, however, that money could be better used for state purposes, a purpose that I totally disagree with. I think this money, this \$4.1 million is committed to property tax relief. My proposal would have left it as property tax relief, and since I don't any longer want to see this bill hang around so there is much confusion, I would urge this body to withdraw the bill.
