Taiwan, and to answer Senator Wesely's question, is it going to make Red China unhappy? Are they going to call me or Senator Remmers naughty names for voting for it? I don't think so but they are going to be aware of the fact, they are going to be aware of the fact that this particular state which they have to rely on for agricultural products, too, isn't going to play the game of, we want to be your friend so we stab our old friend in the back. We will export grain to any of them and food, but not on terms of tit for tat, stab old friends for new friends. I urge you to support the resolution.

PRESIDENT: The question before the House is the adoption of LR 5. All those in favor vote aye, opposed may. Have you all voted? Record the vote.

CLERK: 35 ayes, 3 mays on adoption of the resolution, Mr. President.

PRESIDENT: The motion carries. The resolution is adopted. Anything to be read in before we go into introduction of bills?

CLERK: Well one thing, Mr. President, your committee on Urban Affairs would like to have an executive session for Monday, January 19, 1981, upon adjournment.

Mr. President, your committee on Ag and Environment whose chairman is Senator Schmit gives notice of public hearing in Room 1520 for Friday, January 30. (See page 199 of the Legislative Journal.)

PRESIDENT: We are ready then for agenda item #5, introduction of new bills. Mr. Clerk, you may proceed with the reading of the new bills to be introduced today.

CLERK: Read title to Limber 3 are found on pages 198-200 of the Legislative Journal. Mr. President, in conjunction with that bill we have a communication from the Governor advising the Legislature as to the intent of the bill and the supplemental appropriations required by various state programs. That will be inserted in the Legislative Journal. (See pages 203-204.)

Readtitle to LB 233-246 as found on pages 200-203 of the Legislative Journal.

Mr. President, your committee on Public Works gives notice of hearing for January 30 and February 6 and that is signed by Senator Kremer as chairman.

Ron Severson, teacher. They are up here in the North balcony. Would you indicate your welcome to Norris. Welcome to your Legislature. Why don't you read some matters in at this time, Mr. Clerk, and then we are about ready to commence Final Reading.

CLERK: Mr. President, Senator Landis would like to print amendments to LB 499 in the Journal.

Mr. President, Senator Koch moves to reconsider the body's action on the indefinite restponement of LB 318. That will be laid over.

Mr. President, your committee on Appropriations whose Chairman is Senator Warner reports LB 232 to General File with amendments. That is signed by Senator Warner as Chairman.

Mr. President, I have received a report pursuant to LE 722 from the Nebraska Derartment of Roads.

RECESS

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Record your presence. Have you all recorded your presence? Has everybody recorded their presence so we can start with the perusal of the budgets? Senator Beutler and Senator Newell, would you please record your presence? Okay, record.

CLERK: There is a quorum present, Mr. President.

SPEAKER MARVEL: Before we get into the budget matters, I will introduce from Senator Remmers' District 22 students from Dawson-Verdon School at Richardson County, Karen Flynn, Fred Mack are the teachers. Will you raise your hand so we can see where you are? Welcome! And also in the North balcony, 53 members of the Nebraska Health Care Association. Jim Brown is the Director. Where are you folks? Welcome to you! Senator Warner, are you ready? Senator Warner, you are not ready. Should we try it anyway. Okay. I am sorry. The Clerk will read the title and then we will proceed.

CLERK: Mr. President, LB 232 (Read title). The bill was first read on January 16, referred to the Appropriations Committee for hearing. The bill was advanced to General File. There are committee amendments pending, Mr. President.

SENATOR WARNER: Mr. President, members of the Legislature, I move adoption of the committee amendments. The blue sheet that was passed out by the Pages carries the itemized list of the recommended changes of appropriations during the current fiscal year and the total dollar impact is about two and a half, \$2.6 million, as I recall. I might make a couple of general statements before we start the whole process, Mr. President. First when we get to the other regular appropriation bills, I will use this blue book that was passed out to the members, to your offices, which is easier to follow than the appropriation bills themselves, although there are language from time to time that we may want to identify. Secondly, I would intend not to make any comment other than they are a deficiency bill about the contents themselves in any detail at all on the assumption that we did have a couple of evening meetings in which we spent three hours or better for those who could attend going into more detail, and that to save time I won't go through all that again this time. I would make the one general comment, Mr. President, relative to the appropriation bills this year, I recall that during the years Senator

Marvel was Chairman of Appropriations, he frequently described the budget process as the Uniform Distribution of Dissatisfaction and I would be rleased to report that we have probably reached the ultimate of uniformity this year in that everyone seems to be somewhat distraught with recommendations from Appropriations, and ty virtue of the fact that it is a very tight budget. When you have tight budgets, you obviously have had to say "no" to many requests that probably were proper and orderly and desirable but not within the funding capabilities as we saw them. The deficiency bill has these adjustments. The Supreme Court, there is a couple of adjustments for general fund. They are picking up lapsed federal funds in both cases. I think we anticipated these would occur. One of them deal: with judicial education and training which a portion...half of the funds were ricked up. Another deals with appellate case processing which is the voluntary settlement process. There is some rick up there of \$8,000. In the district courts again picked up part of the funding for judicial training program of the district judges. Secretary of State, there is a small increase for some utility costs for their storage center which last year's bill did not include. Where you see an asterisks is adjustment in the salary limit ir last year's bill but no additional funds are required. Those are always within the available revenue of the department. State Auditor deals with an increase in cash funds authorizing ... permitting them to do some audits for federal grants which the cast actually is federal funds that are paid to the auditor for doing their claimed property which was greater than what they had anticipated. The major impact in terms of dollars, now we deal with the Department of Education, all of which in the major increases deal with the mandated statutory reimbursement by the Legislature for either wards of the court or special education and, again, these are always reimbursed after the fact by law. The initial estimates are always conservative and we always articirate some adjustment is to be required. The other adjustments in the Department of Education are relatively minor and are almost self-explanatory. The State Fire Marshal's Office is also a minor one. It deals with the electrical board in which there was a change in management. They didn't get encumbrances done properly that should have been done. It straightens them out. The Department of Labor is some federal funds they can use for admiristering the state emrloyment security act. They had not been authorized previously. Institutions, a large dollar amount, \$790,000, this is to replace operating money that was used to do some of the initial remain work as a result of the tornado damage at Grand Island Veterans Home. The Department of Welfare is substantially all reductions in general fund

because the anticipated cost was in almost every case less than had been anticipated. We were able to make reductions in authorization. The last item shows where we had in the bill last time language anticipating some revenue sharing funds to not be available and this clarifies the language so it is general fund but that we had included in the bill last time in anticipation. The difference is that we had \$7.5 million of possible general fund pickup. We only need to use 6.2 and the other 1.3 million is available to the agency and would be used. The Department of Veterans Affairs reflects again a small adjustment because of federal funds of not being continued although this will not be continued on through the following year. The Military Department, the \$700,000, it goes to the Governor's emergency fund. together with next year's budget will provide an anticipated \$800,000 level of appropriation for the emergency fund this year. It is expected about \$300,000 carryover from the \$700,000 and then there is \$500,000 new and that is after all the anticipated costs that are reimbursable have been either paid or encumbered for the Grand Island tornado. The tuition credit reimbursement is no additional cost. It is a shift between two programs. State Racing Commission is just additional authorization of expenditure of additional racing days. They should have additional income as a result of that, no general fund. The Department of Corrections, there are three or four things there. There is \$56,000 to complete the interior of the vocational trades building at the Correctional Center. The next one replaces some laundry equipment that was destroyed at a fire there and it was intended that that equipment be transferred to the new building and this replaces the equipment which is or will be installed in the new facility and the next one, \$22,000, is only picking up of some general fund money that was anticipated to be cash and this is the work release centers where I suppose by virtue of a combination of several reasons there are not as many people on work release as has been anticipated. They pay a part of the cost of these overhead costs of the facilities that they stay in while on work or education release, and since it came up short, we had to make it up with general fund money. All of the changes in the Board of Trustees of State Colleges merely reflects the distribution of a discretionary fund by the board to each of the campuses. The balance of the adjustments for the State Colleges are either adjustments in revolving funds were as a result of vetoes by the Governor in last year's budget of general fund money and the revolving fund needed to be increased to cover that or there were increases in their cash fund authorization reflecting additional enrollment above and in excess of what the estimate was. The large item of \$480,000 for Wayne State

College represents no increase in the appropriation but merely accelerates the pay or cash flow needs for construction that is going on there now that is well ahead of schedule and so they can pay the contractor accordingly. Oil and Gas Commission is for the...reflects the additional cost yet this year for uranium test holes paid out of their cash funds. There will be a substantial increase in next year's budget for this same reason. Crime Victims Board increase merely reflects the amount of claims they have allowed to date and anticipate to be allowed. Under the existing law they have to prorate. This is what is required so they will not prorate for those reimbursements. Landscapes and architects, a very minor adjustment but it gets them out of a problem that they have had to roll bills for a couple of years and the next biennium this amount is not carried forward but gets them a clean operation. The Hearing Commission again is just an adjustment in the allowance for salaries. increase in the budget and the last one deals with the Political Accountability Director's salary. It was increased last year by the board by virtue of legislation that had been enacted taking the ceiling off and this allows the adjustment in the salary for the director beginning as of the date he was hired. Their initial request was from the time the agency was established but the committee did not believe that was appropriate, and that, I hope, will be my longest explanation of any of the bills other than response to questions. I move the amendments be adopted.

SPEAKER MARVEL: The motion is the advancement of the bill. Senator Beutler, your light is on.

SENATOR BEUTLER: Mr. Speaker, members of the Legislature, just a couple of questions to clarify the process for me. Senator Warner, if you would, first of all, what is the total deficit appropriation all added up?

SENATOR WARNER: The total deficit deficiency general fund is \$2,536,155. Cash fund is \$255,650. Federal fund is \$91,765. Revolving is \$59,881. The significant figure, the total is \$2.9 million, a little over. The significant figure would be \$2.5 million general fund. It would be higher, you understand, were it not for the fact there are substantial reductions in welfare's budget of general fund money during the current year.

SENATOR BEUTLER: Okay, with regard to how an agency goes about getting a commitment on a deficit appropriation, if, for example, in the case of the Grand Island tornado, there were certain repairs that had to be made and if the agency knew that the money was not in the current appropriation or

in the current emergency fund to make those repairs, then before it entered into a contract it had to have some kind of reliance that the money would be there to pay that contract, I don't understand that process fully. How does the agency head know from the Legislature that there will be this kind of an appropriation to pay those contracts at the appropriate time?

SENATOR WARNER: There is no official way that they could know as such. In the case of the Grand Island situation, first there is an emergency fund for disaster which was established some years ago other than the Governor's emergency fund for which I think we have only appropriated money once or twice in the last ten years. So under existing appropriations and existing practices if this kind of a situation arises they have to utilize some operating funds which they could legally do to make those emergency repairs. Specifically in the Grand Island case they did make some initial repair that was relatively inexpensive, comparatively inexpensive, and then as I recall, there was a second storm that came along, not a tornado, but a storm of sufficient violence to destroy some of the temporary work and then there was substantial damage or possible potential damage. There was communications at that time between the Department of Administrative Services and myself and I believe, as I recall, to the Appropriations Committee during that same process which we all acknowledged that no one had the authority to make a commitment that the funds would be picked up, if they used the operating money, but obviously it was a good and necessary decision to make the repairs immediately and I think the Senators on the Appropriations Committee during, and this is over a month and a half or so. probably made an individual concurrence that they felt it was the proper thing to do and would in fact support replacement of that operating money. And then when the request comes through, that, of course, is what we are suggesting to you. If the Legislature refuses to do it, the agency is just out of that of their operating money.

SENATOR BEUTLER: Okay, so, for example, if I understood the chronology of the events in Grand Island properly, there was a point in time when they could have entered into contracts prior to the storm of August that caused further damage and some of the executive branch people indicated that the contracts were not entered into and the work begun before that second storm because they had no assurances with regard to appropriations. Given the history of deficit appropriatons and the method that has traditionally been used in Nebraska, is that a valid reason for not proceeding to enter into contracts for immediate

repair of buildings that are exposed to weather?

SENATOR WARNER: In retrospect, obviously, Senator Beutler, it would have been better to have made more extensive alterations immediately. I think what they did most immediately was the kind of emergency thing that probably was the only practical thing that could be done in a very short period of time and that might have been sufficient had not the second storm came and I suppose they feel like I feel when I don't take hail insurance out on the wheat field and it hails the week before I decided I ought to do it. You know, obviously I was wrong but I was not necessarily wrong at the time only in retrospect.

SENATOR BEUTLER: Okay, thank you. Thank you, Mr. Speaker.

SPEAKER MARVEL: The motion is the adoption of the committee amendments. Senator Kahle.

SENATOR KAHLE: Mr. Speaker, just one question of Senator Warner, too, if I could. On the Department of Welfare, is this actual money that was not spent last year, then, or is that the predicted cost for next year?

SENATOR WARNER: No, this would all reflect 80-81 appropriation. As I am sure you know all those welfare projected general fund requests are on a projection basis and usually there is some adjustment almost always up or down. We obviously were a little high last year.

SENATOR KAHLE: This does not indicate that the cost of the welfare program has gone down, does it?

SENATOR WARNER: No. It did not go up as much as we had anticipated.

SENATOR KAHLE: Okay, that answers my question, thank you.

SPEAKER MARVEL: The motion is the adoption of the committee amendments as explained by Senator Warner. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 28 ayes, 2 nays, Mr. President, on the adoption of the committee amendments.

SPEAKER MARVEL: Motion is carried and the committee amendments are adopted. Now we are ready for, what, LB...okay, the motion now is the advancement of the bill first. All those in favor vote aye, opposed vote no. Have you all voted? Have you all voted? This is advancement of the bill. Record the vote.

CLERK: 26 ayes, 2 nays, Mr. President, on the motion to advance LB 232.

SPEAKER MARVEL: The bill is advanced. We now go to LB 160.

CLERK: Mr. President, LB 160 (read title). The bill was read on January 14, referred to Appropriations. The bill was advanced to General File, Mr. President.

SPEAKER MARVEL: Senator Warner.

SENATOR WARNER: Mr. President, I move that LB 160 be advanced. As the title states, it is the salary bill for the members of the Legislature and as required by the Constitution contains no other subject and reflects the full authorized expenditure of the Constitution of \$400 a month. I move the bill be advanced.

SPEAKER MARVEL: The motion is to advance LB 160. All those in favor of advancing the bill vote aye, opposed vote no. Record the vote.

CLERK: 29 ayes, 0 mays on the motion to advance 160, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. Are you ready to discuss 161?

CLERK: Mr. President, LB 161 offered by the Speaker at the request of the Governor. (Read title). The bill was read on January 14, referred to Appropriations. The bill was advanced to General File. There are committee amendments pending, Mr. President.

SENATOR WARNER: Mr. President, I move LB...there are committee amendments?

CLERK: Yes, sir. (Read Standing Committee amendment found on page 1457 of the Journal.)

SENATOR WARNER: I move adoption of the amendments. The two amendments reflects the adjustment in the salary reflecting the state salary policy of the court reporter of the Supreme Court and of the Tax Commissioner's Office. Right? Excuse me, no. I am sorry. It is the Clerk of the Supreme Court and the court reporter only. I move that the amendment be adopted.

SPEAKER MARVEL: The motion is the adoption of the committee amendments to LB 161. All those in favor of adopting those

PRESIDENT: Roll call. Has everybody registered your presence? Record the presence. Mr. Clerk.

PRESIDENT: He is ignoring you as only he can do. He is over there ignoring you, he is so surrounded by... you missed your chance. We will go ahead then to the next item, under agenda item number five, which is on motions on returning to Select File for specific amendment, the budget, starting with LB 232, Mr. Clerk.

CLERK: (Read the record vote as found on page 1818 of the Legislative Journal.) 45 ayes, 0 nays, 2 excused and not voting, 1 present and not voting. Mr. President.

PRESIDENT: LB 163 passes with the emergency clause attached. The next bill on Final Reading is LB 557.

CLERK: (Read LB 557 on Final Reading.)

PRESIDENT: All provisions of law relative to procedure having been complied with, the question is, shall LB 557 pass with the emergency clause attached? All those in favor vote aye, opposed nay. Record the vote.

CLERK: (Read the record vote as found on page 1819 of the Legislative Journal.) 47 ayes, 1 may, 1 excused and not voting, Mr. President. May 7, 1981
