Some of the senators here were here at that time and going back to the testimony, it was a pretty lengthy debate, there was a lot of work that was put in on it. Senator Kremer was here. Senator Warner, and many of the others, Senator Carsten and so forth. But as the bill passed across from committee hearings and came here on the floor there was considerable debate upon it, and in the last moments of that bill's passage there was a concern about NRDs and building maybe, so to speak, castles. The amendment was put in there to eliminate anything like this. Since that time there has been approximately ten years that have passed. The NRDs are
