SPEAKER MARVEL: The motion is carried, the bill is advanced. The next bill is 248.

CLERK: We have an A bill on 334.

SPEAKER MARVEL: Okay, the Clerk will read the A bill.

CLERK: Mr. President, LB 334A, offered by Senator Warner, read title.

SPEAKER MARVEL: Senator Warner.

SEANTOR WARNER: Mr. President, I move the A bill be advanced. It only provides the cash fund authorization for the coordinating commission as Senator Koch pointed out, a portion of their duties because of legislation enacted a couple of years ago or one year ago which they license private institutions from out of the state that come in and want to offer some courses, usually those are extension in nature and this is the appropriation of \$500 for the current year 80-81 plus \$500 for next year for 81-82. This bill has the emergency clause. It should be funded yet this year and it is possible that some of these institutions may make application before July 1st. There should have been a cash fund established when the original legislation was enacted either last year or the year before. It wasn't and the bill takes care of the lack of that cash fund authorization and it provides the appropriation for the current two years. I move the bill be advanced.

SPEAKER MARVEL: Motion is the advancement of the bill. All those in favor vote aye, to 234, opposed vote no. 334. LB 334. Record.

CLERK: 27 ayes, 0 mays on the motion to advance the A bill, Mr. President.

SPEAKER MARVEL: Motion is carried, A bill is advanced.

CLERK: Mr. President, LB 248 was introduced by the...Senator Steve Wiitala. Read title of bill. The bill was first read on January 16th and referred to the Retirement Systems Committee. The bill was advanced to General File. There are committee amendments pending, Mr. President, by the Retirement Committee.

SPEAKER MARVEL: Senator Fowler.

SENATOR FOWLER: Mr. President, I would move for adoption of those amendments. To briefly explain 248, it is a bill that Senator Wiitala introduced to try and upgrade in a small way the teacher's retirement system. It does so by changing the final years or the basis for calculating the retired benefits from the five best years of salary to the three best years. This is in conformity with the principles the Retirement Committee has used as far as a target goal for retirement benefits. establishes a benefit that an average teacher in Nebraska if they retired would retire at about 76% of salary, 40% of that is the Social Security, the other 36% is the teachers retirement benefit. The change that the committee added was to change what is called the service annunity which is the state's portion of contribution to the school employee retirement system. The reason to change the service annuity is really twofold. One is to reduce the cost of Senator Wiitala's bill, the fiscal impact to the school district. The second is to provide a benefit, a slight increase for teachers already retired. So, it raises the service annuity from three dollars a month per year of service to \$3.50, a small increase but one that would help reduce the cost to school districts and provide some relief to those already retired. The committee amendments also clarify eligibility for the new retirement computation as far as taking effect for people retiring next year as opposed to this year. increased cost to the school district would be considered a new program and for one year then would be exempt from the lid. I would move for adoption of those amendments.

SPEAKER MARVEL: You heard the motion, the explanation, all those in favor of advancement of the bill....okay, this is the committee amendment. Those in favor of the committee amendment vote aye, opposed vote no.

CLERK: 25 ayes, 0 mays on the adoption of the committee amendments, Mr. President.

SPEAKER MARVEL: Senator Wiitala, do you want to explain the bill.

SENATOR WIITALA: Mr. Speaker, members of the Legislature, LB 248 proposes to amend the school employees' retirement system in arriving at the final average compensation figure. Basically this retirement program covers all school employees who are working more than half time, teachers, administrators, custodians, bus drivers, cooks, nurses, etc. The retirement

program formula is set up where you take the number of years of service times the average of the best five highest years of earning, times 1.25% in order to arrive at the final average compensation. LB 248 proposes to use the three highest years of earnings rather than five. Really a modest change keeping the retirees abreast of inflation. I would like to give you an example. Let's say that we had a teacher who started in 1967 and who will retire 25 years later in 1992. The increase in retirement would be a modest \$26.05 monthly or a total per year increase of \$312.50. committee amendment would increase the state contribution to the service annuity and originally this was part of the original teacher retirement program and many teachers that retired before 1968 retired on that annuity program. For the retired teacher, who retired before 1967, it would increase the state' contribution to the annuity plan by 50¢. In other words the state would be giving the retired teacher \$3.50 per month per year of service. In terms of how it would affect that teacher it would be an increase of about \$20 per month. For these older retired teachers I would just like to cite a letter to this body that, as I was browsing through my mail, today, I felt that it was very appropriate. It is written from Mary Hoagland from Hastings, Nebraska. "Dear Senator: We appreciate your sponsoring LB 248. I taught school in Nebraska for 42 years. My retirement check is \$156.08 a month. This bill, if passed, would increase my check by about \$20 per month which would be greatly appreciated. My \$156 does not pay the rent, let alone the utility bills. I need every dollar increase that I can get. Please do your utmost to see that this bill is passed." The retirement program is sort of like a three legged stool, each leg representing a portion of the contribution of the entire program. The teachers bear the, teachers, custodians, the employees bear the brunt of the expense by paying in 3½% of their salary per year towards retirement. The state has been kicking in \$3.00 a month. Then the school boards are asked to fund the difference and the difference is set by an actuary. Just in closing I would like to remind the body that LF 248 was advanced from committee without opposition. It was heard in committee without opposition. The Lincoln School Board has just endorsed the proposed changes in this bill and also I would like to remind you that there has been no amendments to the retirement system since 1975 that we have gone through several years of high inflation. With that I would ask this body to advance LB 248. Thank you Mr. Speaker.

SPEAKER MARVEL: Senator Remmers.

SENATOR REMMERS: Mr. Speaker, members of the body, I would like to just make a few comments. I am a little bit reluctant because you might say it is sort of a special interest bill but I will assure you it is not going to affect my pension very much but I do think that we need to make some adjustments in teacher retirement benefits. I think first if we look at comparison with other states, I believe of the entire midwest, we rank at the bottom, and when on top of that you add the fact we probably rank about 35th in salaries, and Nebraska is not a poor state. I believe generally we rank somewhere in the middle or above average on personal income so we are not a poor state. I think we can afford to pay the teachers and I think they are entitled to a better retirement figure than they have. As a superintendent of a small school, I know I have seen many young men that have been in the teaching profession for a few years and the good ones don't stay very long. They drop out because there isn't any future and I think currently with the lid that we have had the last couple of years I think we need to do something to encourage people to get into the education business, to become teachers. They have become very discouraged the last couple of years with the future for Nebraska and I don't think we can afford to do I think we owe our children better than that and I would encourage you to support this bill. I think we still will not rank very high as far as teacher benefits are concerned. I think this is a very modest improvement and I would urge you to support it.

SPEAKER MARVEL: The motion is the advancement of LB 248 as explained. Senator Wiitala, do you wish to close?

SENATOR WIITALA: Mr. Speaker, I would just move to advance LB 248.

It is not retroactive. It does not go back and pick up teachers who are now retired from their various systems. It picks up those who are now teaching but plan to retire at the end of this particular school year. I would urge your support for the amendment. Thank you.
