I doubt that the votes are here for me to put the amendment on this bill that would protect innocent third parties who are hurt or killed as a result of high-speed chases. There just is not enough concern in the Legislature for the victims. So I withdrew the amendment attempting to add that to the bill. I had another amendment which was defeated in the past which would have placed certain restrictions on when chases would occur and when they ought to be terminated, primarily related to trivial offenses or traffic violations but now after reviewing the bill, the blue copy. I have found some serious troblems as I read the bill. I am saying what I say for the record because somebody may be prosecuted under this piece of legislation and I think the record should be clear that on the floor of the Legislature, the issue was raised as to the possible unconstitutionality of provisions in this bill. I would want to call your attention to a case that was decided by the State Supreme Court in 1967 which invalidated another highspeed chase bill because of unconstitutional vagueness.

SPEAKER MARVEL: The Chair recognizes Senator Hoagland.

SENATOR HOAGLAND: Mr. Speaker and colleagues, this amendment strikes the presidential primary provisions of LB 209. It follows the recommendations of the Government Committee in reporting this bill out. I think there has been some criticism of the bill because of the amount of money that it would cost the taxpayers to schedule a special separate presidential preferential primary. I don't think that there is much support in this body for this particular aspect of LB 209 and this amendment would clean the bill up to that respect. I would be pleased to answer any questions anybody might have about it. I am sure Senator Koch would as well. I ask for your support for this amendment.

SPEAKER MARVEL: The motion before the House is the Hoagland amendment. Any further discussion? All those in favor of the adoption of the Hoagland amendment to LB 209 vote aye, opposed vote no. This is the...have you all voted? Have you all voted? Senator Hoagland, what is your pleasure.

SENATOR HOAGLAND: Yes, this amendment, Mr. Speaker, strikes the presidential preferential primary which I think has received a lot of opposition and I see that we need about 8...I hate to have a Call of the House...waiting for people to come back into the Hall from lunch so I would be content

the bill to E & R for Review. All those in favor of that motion vote aye, opposed vote no. Record.

CLERK: 30 ayes, 5 nays, Mr. President.

SPEAKER MARVEL: Okay, the motion is carried. The bill is advanced. This is to remind you that at least to begin with, well, we will meet tomorrow at 8:00. We have got three and a half hours of Final Reading. Senator Kahle, do you want to adjourn us until eight o'clock tomorrow morning. Wait a minute...just a minute. Mr....go ahead.

SPEAKER MARVEL: Your point is well taken. Thank you, sir. Senator Vard Johnson, your light is on. Senator Kahle.

SENATOR KAHLE: Mr. Speaker and members, I move that we adjourn until eight o'clock tomorrow morning. I would also request that we be allowed to check in tonight. Forget the last part of it.

SPEAKER MARVEL: We are adjourned until eight o'clock tomorrow morning. All those in favor say aye. Opposed no. Motion is carried. We are adjourned until eight o'clock tomorrow morning.
