SPEAKER MARVEL: Before we return to LB 287 I would like to once again give you nine numbers to look at and the first one is 649, 571, 597, 598, 646, 654, 692, 628, 630. After we get through with 287 then we will revert to these particular bills we just enumerated. LB 287.

CLERK: Mr. President, LB 287 offered by Senator Rumery. (Read title.) The bill was read on January 19 of last year, referred to the Retirement Systems Committee for hearing. The bill was advanced to General File, Mr. President. There are committee amendments attached, Mr. President.

SPEAKER MARVEL: Senator Fowler, do you wish to discuss the committee amendments?

SENATOR FOWLER: Yes, I think I have an amendment to the committee amendment up there. Is that correct, Pat?

CLERK: Yes, sir, you do.

SENATOR FOWLER: Okay, yes, I need to move the technical amendment to the committee amendments. Maybe I should explain the bill and the amendments and explain what the technical amendment does. Okay, the bill is Senator Rumery's bill and it originally introduced for public employees abolished mandatory retirement. Currently the retirement age is seventy. A couple systems allow an extension for a year or two, up to seventy-two. That was the original bill.

Some folks had some objections to the concept of completely abolishing mandatory retirement so we came in, had an interim study. The committee went around the state. People testified and we decided on a compromise that would allow a person to work past age seventy on a year by year basis with the consent of the employer. So there is a retirement age of seventy and you can work beyond that on a year by year basis if the employer consents. And again, we're talking just about public entities, cities, counties, school districts and so on. We had a hearing on that proposed compromise and it was acceptable to everyone. No one objected to the concept of allowing an option for work beyond seventy if it is agreeable to the employer. So that is what the committee amendment does. Now the amendment to the amendment is a technical correction for institutions of higher education for tenure. Tenure is the ability to keep your contract. Well, we had to make it clear that past age seventy you could not have tenure because you are on a year by year contract and so definitionally you can't be on a year by year contract and have tenure at the same time. So this says that after age seventy you cannot have tenure. You would work on a year by year basis with the agreement of your employer. So that is the technical amendment from the committee. It deals with tenure and then the committee amendment amends the bill so that we reinstate a retirement age of seventy but do allow people to work on a year by year basis with the consent of the employer. So first, I would move adoption of the amendment to the committee amendment and then the committee amendment.

SPEAKER MARVEL: Senator Kahle, do you wish to be recognized?

SENATOR KAHLE: Yes, Mr. Speaker and members, I did attend the hearing that was held out at Kearney that Senator Fowler conducted and I believe what he is saying is what we thought would be the best approach. The tenure thing of course, you can't have tenure on a year to year basis. One of the things that we were concerned about and, Senator Fowler, you might help me out on this, was the salary base. Of course, if I understand you correctly that is also negotiable on a year to year basis. Is this correct? Okay, with that explanation I think probably this is the way it should be handled and will support the amendment and hopefully later the bill.

SPEAKER MARVEL: The motion now is the amendment to the amendment as explained by Senator Fowler. All those in favor of the amendment to the committee amendment vote aye, opposed vote no. Record.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of Senator Fowler's amendment.

SPEAKER MARVEL: And now the committee amendment.

SENATOR FOWLER: (Mike not on.) ...adoption of the committee amendment which changes Senator Rumery's bill from the concept of eliminating mandatory retirement to reinstating a retirement age of seventy but allowing a process of essentially negotiation between the employee and employer as to the possibility of continuing employment, perhaps on a partime basis, whatever. But basically it is a renegotiation on a year by year basis if the employer feels that the employee has special value, can handle the job and so on, wishes to retain him and the employee wishes to continue to work, would be negotiated on a year by year basis and I think it is an acceptable compromise that allows people to work past age seventy if they are able and if the demand for their skills is there. So I would move for the adoption of the committee amendment.

SPEAKER MARVEL: The Chair recognizes Senator Stoney.

SENATOR STONEY: Mr. Speaker, a question of Senator Fowler if he would respond, please. Senator Fowler, I have not had an opportunity to look at this closely but thought perhaps you could answer a question with me relative to the negotiation process subsequent to age seventy. Now through this process if the school district decides that they do not wish to renew the contract of this individual, what recourse is there on the part of that individual in challenging that decision that is made by a school district or a school board?

SENATOR FOWLER: None. Essentially the bill says you are retired at age seventy unless you can persuade them or work out something that you can continue to work beyond that and then you could get a one year extension. So the recourse would be, I mean, none. You are essentially retired at age seventy and then it is up to...you've got to persuade the school district if they will keep you on and then if they decide not to and they don't even have to justify that decision, you would hope that they would work with the employee and provide a rationale but if they decide as a policy or whatever, this bill would let them retire that person.

SENATOR STONEY: Thank you, Senator Fowler. I think that answers my concern. I felt if the board made the determination or the judgment that they did not wish to continue that individual for an additional year then I was concerned if there would be a process where it could be long and involved or drawn out and quite costly to the district in making that determination. So that certainly answers the question. Thank you.

SPEAKER MARVEL: The motion is the adoption of the committee amendment. All those in favor vote aye, opposed vote no.

CLERK: 27 ayes, 0 mays on adoption of committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried. The committee amendments are adopted.

CLERK: Mr. President, Senator Rumery had amendments to the bill on page 93 of the Journal. I understand he wishes to withdraw those. Is that right, Senator?

SENATOR RUMERY: Yes, that is correct. That does the same thing as this last committee amendment.

CLERK: Mr. President, Senator Rumery would then move to amend the bill by adding the emergency clause.

SPEAKER MARVEL: Any objection? So ordered. Okay, all those in favor of the adoption of the committee amendment... adoption of the emergency clause, all those in favor vote aye, opposed no. Have you all voted? Record.

CLERK: 26 ayes, 0 mays on adoption of Senator Rumery's amendment. Mr. President.

SPEAKER MARVEL: The motion is carried. The amendment is adopted. Senator Rumery, do you wish to explain the bill?

SENATOR RUMERY: Mr. President, members of the Legislature, LB 287 simply repeals the state law requiring all employees of state and city and county government, school districts, the University of Nebraska, state colleges and technical community colleges to retire at age seventy. Present law permits the few select employees to work to age seventytwo if the employer requests the annual waiver. LB 287 would allow all capable employees the option to continue working. It will not mandate persons to continue to work past the normal retirement age which is considered to be sixty-five. It would allow those persons to continue working for economic or personal reasons of need or they want to. 287 does not propose any change in the existing provisions that define the retirement contributions with employees or benefit amounts for employees who remain beyond the normal retirement age. It does recognize that job performance is not, recognizes that the job performance is not age related. To mandate any age as the required retirement age is both arbitrary and discriminatory because it does not consider individual ability. Six states have

repealed the mandatory retirement for public employees and the United States Government has repealed the mandatory retirement age for federal workers. As the baby boom population ages and the number of workers supporting retirees decreases, it is time to evaluate the labor market and state retirement policy. The intent of 287 is to remove artificial and arbitrary barriers to the continued employment of efficient and capable older workers. And I might say that these workers continue to be taxpayers instead of tax users. Mr. President, I move the advancement of the LB 287.

SPEAKER MARVEL: The motion is the advancement of the bill as explained by Senator Rumery. All those in favor of advancing the bill vote aye, opposed vote no. Record the vote.

CLERK: 30 ayes, 1 may, Mr. President, on adoption of or advancement of the bill.

SPEAKER MARVEL: The motion is carried and the bill is advanced. The next bill is LB 649.

CLERK: Mr. President, LB 649 offered by the Administrative Rules and Regulations Committee and signed by its members. (Read title). The bill was read on January 6 of this year. It was referred to the Administrative Rules Committee for public hearing. The bill was advanced to General File, Mr. President.

SPEAKER MARVEL: Senator Vard Johnson, do you want to explain the bill and then move to advance it?

SENATOR V. JOHNSON: Mr. Speaker and members of the body, I would hope that you would listen to the presentation on this particular legislative bill because this will be the first presentation that has been made on the floor of the Legislature with respect to a matter that has been in our statutes for some time. This is a fairly unique situation. What legislative bill 649 does is it repeals regulations that were adopted last year by the Board of Public Roads Classifications and Standards. Now in 1980 this Legislature passed LB 873 which added one additional classification for highways in the State of Nebraska, and that classification was for scenic recreation roads. It was a new highway classification. After we passed LB 873 in 1980, the Board of Public Roads Classifications and Standards held hearings to determine how this new classification should be implemented through the regulatory process. Following the hearings by the Board of Public Roads Classifications and Standards they adopted regulations concerning which roads could then be designated as scenic recreation roads. committee i.e. the Administrative Rules and Regulations Review Committee received a complaint from Senators Hoagland and Beyer in which those two Senators claimed that the regulations adopted by the Board of Public Roads Classifications and Standards Committee did not comport with LB 873. They were beyond LB 873. They did not deal with the intent of the Legislature. Now the Administrative Rules and Regulations Review Committee held a public hearing last summer. We held it in Johramm Park which as you may know is where the Omaha World Herald's fish display is. It is a nice park by Gretna outside of Omaha. We held it there because one of the scenic roads to be affected by the regulations is Highway 31 which goes by the old fish hatchery. The committee took considerable public testimony with respect to what was the intent behind LB 873 and in addition what was the intent behind the regulations. The committee concluded that it was absolutely true, as Senators Beyer and Hoagland pointed out, that the regulations did not conform
