CLERK: Mr. President, an announcement from the Speaker regarding LB 547 being moved from Passed Over to General File.

Senator Koch would like to be excused Thursday morning.

Senator Clark would like to print amendments to LB 571; Senator DeCamp amendments to LB 358. (See pages 722-723 of the Legislative Journal.)

Your committee on Banking, Commerce and Insurance whose chairman is Senator DeCamp instructs me to report LB 626 advance to General File and LB 595 indefinitely postponed, both signed by Senator DeCamp.

Mr. President, LB 634 was a bill introduced by Senator Newell. (Read title.) The bill was read on January 6 of this year. It was referred to the Constitutional Revision and Recreation Committee for public hearing. The bill was advanced to General File, Mr. President. There are committee amendments pending by the Constitutional Revision and Recreation Committee.

SENATOR LAMB PRESIDING

SENATOR LAMB: Senator Labeledz, do you wish to handle the committee amendments?

SENATOR LABEDZ: Thank you, Mr. President. LB 634 was introduced by Senator Dave Newell and the committee amendments are just correcting some language. The insertion of "use by" was for grammatical clarity, the words, "or financing" were added so that property and blighted areas could benefit from the federal income tax exemption on bonds without the requirement that the municipal corporation own the property. If there is further explanation of the bill I'm sure Senator Newell will be able to do it. I move for the advancement of the committee amendments on LB 634.

SENATOR LAMB: The motion is to adopt the committee amendments. All those in favor vote aye, those opposed vote no.

CLERK: Senator Lamb voting yes. 28 ayes, 0 nays, Mr. President, on adoption of committee amendments.

SENATOR LAMB: The committee amendments are adopted. Senator Newell, do you care to explain the bill?

SENATOR NEWELL: Mr. President, members of the Legislature, LB 634 is a constitutional amendment which would authorize the bonds, tax exempt bonds for the financing of business

SENATOR CLARK PRESIDING

SENATOR CLARK: The next bill is LB 816.

CLERK: Mr. President, LB 816 was a bill that was introduced by the Revenue Committee and signed by its members. (Read.) The bill was read on January 13 of this year. It was referred to the Revenue Committee for public hearing, Mr. President. The bill was advanced to General File. There are Revenue Committee amendments pending.

SENATOR CLARK: Senator Carsten, on the amendment.

SENATOR CARSTEN: Mr. President and members of the Legislature, I move for the adoption of the committee amendment. At this point, Mr. President and members, I feel a little washed out and I say that in jest but it has been a long day with water bills and I think we're moving now into an area that we, everyone of us, have a deep concern and that is this distribution of the \$70 million governmental subdivision fund with which we have had so much problems. The committee amendments to the bill and I'm going to take them first and explain them. As amended it revises the distribution of the \$70 million state aid to local government fund. In addition to that \$70 million, \$12.6 million governmental subdivision fund is revised in light of the opinion, #182 of the Attorney General, January 25, 1982. The basic concept of the bill is to place the approximate amount of funds received by the counties, schools, cities and technical colleges into existing state aid funds received by those types of local government...

SENATOR CLARK: (Gavel.) Could we reduce the noise level, please so he can talk.

SENATOR CLARK: Motion lost. Next motion. Yes, go ahead and read some things in. The Call is raised.

CLERK: Mr. President, very quickly, I have an explanation of vote offered by Senators Cullan and Carsten.

Study resolution, LR 334, offered by Senator Schmit and Kremer calls for a study the alternatives of funding water projects, both large and small scale in the State of Nebraska. A study resolution by Senator Koch calls for a study of the philosophy and intent related to the role and mission of the Nebraska Common Schools (LR 333). LR 335 offered by Senators Fowler, Rumery, Goodrich, Warner, and Cullan calls for a study of the various aspects of retirement plans for public employees of the State of Nebraska.

And, Mr. President, Senator Schmit would like to print amendments to LB 358 in the Legislative Journal.

And, Mr. President, I have a motion from Senator Kilgarin to reconsider the vote on Final Reading of LB 672 this morning.
