LB 463, 381

SENATOR FOWLER: LB 463 is a simple bill. It says that people who work beyond the normal retirement age should be able to contribute to a retirement plan up to the age they choose to retire or are required to retire. The bill was introduced to provide uniformity in this area for all retirement systems but a question was raised with regards to the area of public safety, that is, police and fire service, and it was felt that in fact this principle we may not want to extend as broadly to police and fire as we do other areas so the committee adopted an amendment that remove police and fire from this of the primary cities and the first class cities and leave the law as is in those areas. I would move for adoption of that amendment.

SPEAKER MARVEL: The motion is the adoption of the amendment as explained by Senator Fowler. All those in favor vote ave. opposed vote no. Have you all voted? Record.

CLERK: 26 ayes,0 nays on adoption of the committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried. The committee amendment is adopted. Senator Fowler.

SENATOR FOWLER: Mr. Chairman, I would move that the bill be advanced. As I indicated it simply establishes for all the remaining retirement systems the principle that if you work beyond age 65 to say age 70, you work beyond the normal retirement age, you should be able to contribute, continue to contribute to a retirement plan, and then when you retire, the benefits would reflect that contribution. So I would move advancement of LB 463.

SENATOR NICHOL PRESIDING

SENATOR NICHOL: We are voting on the advancement of LB 463. All those in favor vote aye, opposed nay.

CLERK: Senator Nichol voting aye.

SENATOR NICHOL: Record.

CLERK: 26 ayes, 0 mays on the motion to advance the bill, Mr. President.

SENATOR NICHOL: The bill is advanced. We will move on to LB 381.

CLERK: Mr. President, LB 381 (Read title). The bill was read on January 19, referred to Appropriations. The bill

was advanced to General File. I do have committee amendments, Mr. President, by the Appropriations Committee.

SENATOR NICHOL: Senator Warner is not here. Senator Rumery, are you going to handle these amendments?

SENATOR RUMERY: Mr. President, I move that we adopt the committee amendments.

SENATOR NICHOL: All those in favor of adopting the committee amendments please vote aye, opposed nay.

CLERK: Senator Nichol voting aye.

SENATOR NICHOL: Have you all voted? Please vote. Record please.

CLERK: 27 ayes,0 nays on the adoption of the committee amendments, Mr. President.

SENATOR NICHOL: The committee amendments are adopted. Senator Warner, are you going to take the bill?

SENATOR WARNER: Mr. President, I move that LB 381 be advanced. 381 is the bill that reinstates or continues the Department of Administrative Services. It was subject to the sunset provisions and I can give you a quick rundown of the sections. Essentially it is not to say perhaps that the bill essentially reestablishes the Department of Administrative Services as we know it to exist. There are some sections that are deleted from existing law. By and large those would have been practices that was established back in 1965 that really have not been used or are obsolete and so in essence what the bill does is to have actual practice in the statutes be similar as it is currently practiced. Some of the examples of things that are eliminated that was in the original bill, a requirement for the testing of quality of all products purchased through Materiel. This is something that has never been done. The state is not in a position to do that...that kind of testing. There are some changes required that spells out more clearly what agencies can do in the way of direct purchasing, and rather than going through the central stores, at least here within Lincoln. There are a number of changes that covers the use of those vehicles under Transportation Service Bureau, tightening up such things as the use of cars over the weekend, the markings on these cars, and their title to the TSB as opposed to an agency, but there is no change from any agency that is currently assigned private cars by statute. There is another change in the Building Division.

The old statute required what was called a Comprehensive Capital Facilities Planning which never was really implemented or used and this is changed to provide some really better planning, broader planning, when capital facilities are constructed so that the cost of not only the facility but other changes that might be required. It clarifies the requirement of leases to real property through a bidding process. It currently was not all that clear. It also defines some of the rental charges that DAS can charge for office space as well as parking area and some of the parking funds that are acquired by DAS from parking facilities in downtown Lincoln, those funds are earmarked, in the cash fund, they are earmarked for to assist with restoration of the State Capitol. It includes a number of new sections making out a statement of purpose for different sections within the Department of Administrative Services. This is something that we generally find is lacking when we have done a lot of these sunset reviews and there is a number of those sections put in that spells out what each of these sections are generally required to do. I would be glad to answer any detailed questions about any of the sections somebody wants. I move the bill be advanced.

SENATOR NICHOL: There are apparently no questions so that will comprise your closing, I assume, Senator Warner. We are voting on the advancement of LB 381 to E & R Initial. All those in favor vote aye, opposed nay.

CLERK: Senator Nichol voting aye.

SENATOR NICHOL: Record please.

CLERK: 27 ayes, 0 mays on the motion to advance the bill,

Mr. President.

SENATOR NICHOL: LB 381 is advanced to E & R Initial. We will go on to LB 3.

SENATOR CARSTEN: Mr. President and members of the Legislature, I move for the adoption of the committee amendments. The committee adopted the amendment which substitutes new language for the original bill. amendment provides in esser.ce that the exemption would apply in case of new manufacturing and processing equipment for use in a new manufacturing facility. amendment is specifically targeted for new industry locating in Nebraska and expansion of existing facilities for manufacturing of different types or lines of products. Now the phrase "new manufacturing and processing equipment" is intended to include those types of machines commonly found in manufacturing and processing plants such as press and milling equipment. It is not intended to include the normal business equipment such as electronic data processing equipment, telecommunications equipment, office typewriters and floor buffers. The phrase, "new manufacturing and processing equipment" as used in the amendment excludes farm and ranch equipment. The amendment also requires that the facility be one of new construction begun on or after July 1, 1981. The intent of the phrase "new construction" is generally defined in the amendment, but more specifically the intent is to exempt equipment creating new manufacturing or processing operations. This amendment is designed to encourage new industry location in Nebraska by exempting its machinery from sales and use tax upon entering into the state. Facilities currently located in Nebraska would receive the same exemption upon creating a new manufacturing or processing operation in the state, but would not receive the exemption on new or improved equipment which replaces existing equipment or on new equipment which only expands

SPEAKER MARVEL: Record the vote

CLERK: 14 ayes, 18 nays, Mr. President.

SPEAKER MARVEL: Motion lost. There is still a lot of discussion. Senator Beutler, for what purpose do you arise?
