Mr. President, I have a unanimous consent request to have Senator Clark add his name to LR 16.

PRESIDENT: Any objections? If not, so ordered.

CLERK: Mr. President, LR 16 is ready for your signature.

CLERK: 26 ayes, 0 mays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The next bill is 388.

CLERK: Mr. President, LB 388 was introduced by Senators Wiitala, Schmit, DeCamp, Beutler and Kremer. (Read title.) The bill was read on January 19. It was referred to the Public Works Committee. It was advanced to General File. There are committee amendments pending by the Public Works Committee, Mr. President.

SPEAKER MARVEL: Senator Kremer.

SENATOR KREMER: Again, Mr. Chairman and members of the Legislature, this again is purely a technical amendment. It has to do with an internal problem. It makes reference to Sections 4 and 5 I believe that should be corrected to another section. So I move the adoption of the amendment.

SPEAKER MARVEL: The motion is the adoption of the committee amendments to LB 388. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 28 ayes, 0 mays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. Senator Kremer, have you explained the bill to your satisfaction?

SENATOR KREMER: Mr. Chairman, Senator Wiitala is the principal introducer. He will explain the bill.

SPEAKER MARVEL: Okay, Senator Wiitala.

SENATOR WIITALA: Mr. Speaker, members of the Legislature, LB 388 addresses a problem in Natural Resources Districts whereby Natural Resources Districts cannot provide for special benefit projects that are of a nonrevenue producing nature. For example, I would like to use the union dike, levee, that exists between Valley, Nebraska, and Fremont. The NRD can repair that dike and service it but it cannot improve it largely because as NRDs are constructed they can only create projects that are of a general benefit nature. This bill would provide for projects of a special benefit. There is no fiscal impact that I am aware of that is involved but it will allow citizens out of their own volition to petition for a special project that would benefit a limited number of people in a Natural Resources District,

first by petition and a hearing on the petition and then later by levying assessments on those who are going to be especially benefitted. Without any further ado, unless you have some questions, I would recommend that this bill be advanced to E & R initial.

SPEAKER MARVEL: Senator Vard Johnson.

SENATOR V. JOHNSON: I have a couple of questions, Senator Wiitala, if you might yield.

SENATOR WIITALA: Yes, I will.

SENATOR V. JOHNSON: The first one is this, I guess the City of Omaha is included within a Natural Resource District because we sure vote for Natural Resource District directors. Would it not be possible for example, for the Mockingbird SID, for the persons there who want to construct a community center, to approach their Natural Resource District with petitions and ask that a special improvement area be allowed within that particular SID so that, in fact, such could be done, notwithstanding the laws that we have on the books right now for the SIDs themselves going forward to the local city council and the like for approval of those kind of projects? Do you understand what I am saying, Senator Wiitala?

SENATOR WIITALA: Right, it is my understanding that it would not be. I think you would have to relate to the intentions of most NRDs and that is largely to deal with flood control and watershed problems and projects. If I am not correct in that assessment, I would be willing to yield to anyone that could address that question.

SENATOR V. JOHNSON: Well, I could take it a step further then. I mean, this may be a little bit bizarre but I know what you have in mind with respect to the Union Dike project but supposing that we wanted in a city in an urban center to do something with parks, claiming simply that parks have a certain recreational aspect which does come within some of the purview of the NRD law and we decide that the neighbors want to set up a special improvement area to develop the park. Is there any reason in this legislation why that could not be done, notwithstanding this NRD is operating within the urban center?

SENATOR WIITALA: I really can't answer that question, Senator Johnson.

SENATOR V. JOHNSON: That is okay. I will check it out. The question came up while I was looking at the bill.

The second question I have is this. The Revenue Committee has been putting together LB 167 which is on the floor and it has kind of had some fits and starts and has not gotten very far and I am looking in my black book and I see it has a whole series of amendments to it but that is to set a uniform rate of interest on tax delinquencies and that includes special assessments. In this particular bill the special assessment delinquency rate of interest is whatever is declared by the NRD Board, I mean as I-read the bill. It does not relate to any concept of uniform rates of interest on a delinquency. Would you have any problems, Senator Wiitala, if we were to key the delinquency on special assessments here to whatever we do with LB 167?

SENATOR WIITALA: No, I wouldn't.

SENATOR V. JOHNSON: Okay, thank you.

SPEAKER MARVEL: Senator DeCamp.

SENATOR DeCAMP: Mr. President, just simply to support the bill and say it is really ultimately simple. It is merely a legal financing system so that let's say we forty-nine senators are living in an area where we have had some flood problems and you know where I am talking about over where by...what, on the Platte River over there. It just says we can legally set up a system so we can assess ourselves to pay for it in a uniform fashion and that is about it. I urge you to advance the bill.

SPEAKER MARVEL: Senator Kremer.

SENATOR KREMER: Mr. Chairman, I wish to speak in support of LB 388. The Public Works Committee heard the bill and my name is on the bill. What we are doing here, we are going back to the original concept of 1357 whereby G.O. bonds were eliminated. This bill puts them back in and can be used in special purpose districts, however, it is up to the people. It goes to the people for a vote. Therefore, it is protected and many of these areas within an NRD do have a special need and allows them to assess themselves if they want to and pay for it as they want to in the way these bonds are arranged and sold. I do support the bill. I think it is a good one. We need this to take care of them, the special interests within a Natural Resource District.

SPEAKER MARVEL: Senator Nichol.

SENATOR NICHOL: Mr. Chairman, members of the Legislature, I would have a question of Senator Kremer or Senator Wiitala. Could this project be a 100% recreation?

SPEAKER MARVEL: Senator Kremer. Oh, excuse me.

SENATOR KREMER: I would have to go back and reread the old 1357, however, 1357 did provide that there could be some recreational facilities established or areas established. Now when you say 100%, I would have to do some more checking. I don't know.

SENATOR NICHOL: I am not trying to ruin the bill or anything because I think I am in favor of it. The reason I question it, we are having a bill coming down the pike in a few days that sets that at 50% and I don't know how you figure a percentage of the benefit or cost or whatever is for recreation or something else. So, I just would like to know some time in the future, I'm not attempting to do anything to the bill. Thank you.

SPEAKER MARVEL: Senator Johnson. Senator Kremer.

SENATOR V. JOHNSON: Senator Kremer, my question is simple. Senator Kremer, you said that the issue was put to a vote of the people. The question is, which people, those only within the special improvement district or those of the entire Natural Resource District?

SENATOR KREMER: Those in the special improvement district because they are the ones that are paying the bill.

SENATOR V. JOHNSON. All right, thank you.

SPEAKER MARVEL: Senator Vickers.

SENATOR VICKERS: Mr. President and members, I rise to support LB 388 and in order to hopefully answer some of the questions and the concerns that have arisen this morning, I think we need to examine the Natural Resources Districts and their purposes for which they were created and I certainly stand to be corrected if I am wrong. Senator Kremer knows much more about this subject than I do but as I read Chapter 2-3201, the declaration of intent for Natural Resources Districts, Senator Johnson, I don't believe that the Natural Resources Districts would have the authority to operate as an SID necessarily because I believe the intent was pretty clear in that section that they are dealing with the natural resources of the state. Now I would just suggest that perhaps you read that yourself. I am not quite as clear on law, matters of law as you are of course, but I believe that this is a good bill. Last year or the year before we heard a bill very similar to this and it did not get acted on but I think there is a real need in certain areas of this

state for this type of legislation and would certainly urge the body's adoption of it.

SPEAKER MARVEL: Senator Wiitala.

SENATOR WIITALA: I would just like to clarify some of the processes that the bill addresses. One of my main concerns was, what redress did the public have that they favored or disfavored, the enactment of such a project. I just want the body to understand that such a project is initiated by the landowners or the property owners that are involved and there are provisions there that if 51% of those landowners agree with that project that it can be terminated. In answer to Senator Nichol's question on whether it could be a recreational project, I suppose it probably could be but again, it would be by the vote, it would be by the initiative of those property owners that were involved and I doubt whether the right of eminent domain would probably be used in this as it pertains to this bill.

SPEAKER MARVEL: The motion is the advancement of LB 388 to E & R for review. All those in favor vote aye, opposed vote no. Record.

CLERK: 26 ayes, 1 may, Mr. President, on the motion to advance the bill.

SPEAKER MARVEL: The bill is advanced, Do you have anything to read in before we adjourn?
