The present law requires that they hold all meetings in Lincoln and this bill only provides that they meet at places other than Lincoln and we hope that this will increase the ability of the citizens to voice their views regarding the function of the Commission. I move for the advancement of LB 544.

SENATOR CLARK: The motion before the House is the advancement of LB 544. Is there any discussion? If not, all those in favor of advancing it vote aye, opposed vote nay. Voting aye, Mr. Clerk.
