SPEAKER MARVEL: May I have your attention to discuss item #6 and item #6 has to do with the continuation of the discussion on LB 125. There is a request that the bill be laid over until Monday. I have contacted two of the introducers. They are amenable to laying it over until Monday. If we do this, I think we must do it with the understanding that we are not establishing a precedent. But anyway, is there objection to laying over 125 until Monday? Senator Higgins.

SENATOR HIGGINS: Mr. President, who requested that we lay it over?

SPEAKER MARVEL: Senator Haberman.

SENATOR HIGGINS: Thank you.

SPEAKER MARVEL: Any other discussion? Okay, the bill will be laid over until Monday. We now move to General File, LB 144, Mr. Clerk.

CLERK: Mr. President, LB 491 was introduced by Senator Cope. (Read.) The bill was read on January 20, referred to Urban Affairs. The bill was advanced to General File. There are committee amendments by the Urban Affairs Committee.

SPEAKER MARVEL: Senator Landis.

SENATOR LANDIS: Mr. Speaker, members of the Legislature, the amendments to LB 491, LB 491 is required because of some bad drafting and mandatory language over time which confused the purpose of that section. The amendments that are offered by the committee are grammatical in nature with the exception of the addition of the language approved by the city treasurer and represents simply an attempt to clarify grammatically the purpose of the bill. To adopt the committee amendments is simply to make the purpose of the bill more grammatical at which time then I would turn this over to Senator Cope, I believe it is, who will speak as to the merits of the bill itself. The amendments are the changing of semicolons, the use of the word "either" instead of the word "than" and such changes as that, purely grammatical in nature.

SPEAKER MARVEL: The motion is to adopt the committee amendments as explained by Senator Landis. All of those in favor of adoption of committee amendments vote aye, opposed no. Have you all voted? Record.

CLERK: 26 ayes, 0 mays on adoption of committee amendments.

SPEAKER MARVEL: The motion is carried. The committee amendment is adopted. Senator Cope.

SENATOR COPE: Mr. President and members, this bill was brought in behalf of a first class city through the Bankers Association. The purpose of LB 491 as introduced and amended by the committee amendments is to clarify sections 16-716 which determines how much money a bank in the first class may have on deposit in a bank and how such deposits will be secured. Now, first of all, the banks, the deposits of a city at any one time within a bank cannot exceed paid up capital stock and surplus and that is where clarification is made. As you know, banks have to secure deposits and that is done by pledging securities. There are...sometimes cities at peak times of the year have more deposits than there are capital stock and surplus in even one, two, or three banks, whatever are in the city and this came up at one of the cities and they wanted it clarified to be sure that they were within the law. intent of LB 491 as amended is to make clear that there exists an alternative means of providing security for a city deposit without the artificial limitation of the

amount of capital stock and surplus of that bank. To avail themselves of this alternative, the bank must not have a deposit more than 90% of the par value of approved securities pledged to secure that deposit. Now the question might arise as to who should approve these securities. The committee amendment simply places this responsibility with the city treasurer. Now the state auditor, Ray Johnson, testified and concurs that this section needs to be clarified. With that I would move that it be moved to E & R for initial.

SPEAKER MARVEL: The motion is to advance the bill to E & R for review. All those in favor vote aye, opposed vote no. Have you all voted? Record.

CLERK: 27 ayes, 0 nays, Mr. President, on the motion to advance the bill.

SPEAKER MARVEL: The motion is carried and the bill is advanced and we now go to LB 283.

CLERK: Mr. President, LB 283 was offered by Senator Tom Vickers. (Read.) The bill was first read on January 16, referred to the Ag and Environment Committee for public hearing. SENATOR HIGGINS: Mr. President, I didn't realize we were going to move this fast on Select File this morning, in fact I didn't even know my bill would make it this morning, but I have handed out copies of the amendment. I would briefly explain the amendments this way. The amendments will keep the preference for moncivil protective custody for placement in a clinic, a hospital, a home or a detoxification center. The amendments will also allow a police officer to use the telephone to survey facilities to try to locate one with space. It will also allow an officer to contact only those facilities he knows will be likely to accept the individual rather than go to facilities that have previously had a record of not accepting them. It makes clear that civil protective custody can be used if no other facility is available to provide a place where the intoxicated derelict or alcoholic, whatever, can sleep off his intoxication until he is reasonably sober. Of course the other amendments were previously adopted, the committee amendments on General File.

SPEAKER MARVEL: The motion is the adoption of the Higgins amendment to LB 87. Senator Nichol. Excuse me, I'm sorry, Senator Wesely, you are first and then Senator Nichol.

SENATOR BEUTLER: Mr. Speaker, members of the Legislature, this amendment is also being put on with the approval of the introducer and it addresses itself to the possibility that a loophole may have been created in the law and it is to be sure that a loophole is not created. The bill itself has to do with the deposit of funds by a political subdivision in a bank, and when a political subdivision does that, one of the provisions of the law is that they can deposit up to ninety percent of the par value of the securities furnished by the bank in cases where the bank deposits security is approved by the State Treasurer. The new language is "approved by the State Treasurer". It removes the word "approved" in another section of the law and my question had to do with why that was removed and what I am doing is putting into the statute a reference to 16-715 of the statutes so that we retain the former law, the law that we have always had, that the types of securities that can be put up as collateral have to be those types set forth in 16-715. In the past they have always had to be those types of securities and those are the less speculative securities and I am just being sure that Senator Cope's bill does not change that by referencing that statute, and as I said, this has his approval. Thank you.

PRESIDENT: The Chair recognizes Senator Cope.

SENATOR COPE: Mr. President, members, this is agreeable. It was the intent of the bill, and if this clears it up a little better, that is fine.

PRESIDENT: Any further discussion on the Beutler motion to return LB 491? Senator Beutler, do you have any closing? Closing is waived. The motion is the return of LB 491 to Select File for a specific amendment. All those in favor vote aye, opposed nay. Record the vote.

SPEAKER MARVEL: While the Legislature is in session and capable of transacting business I am about to sign and do sign reengrossed LB 58, reengrossed LB 283, reengrossed LB 491.

CLERK: Mr. President, a request from Senator Haberman to add his name to amendments to LB 284, Request #2325 as coointroducer. (See page 1552 of the Legislative Journal.)

SPEAKER MARVEL: Hearing no objections, so ordered.

CLERK: Mr. President, a new resolution, LR 62, offered by Senator Kahle. (Read. See pages 1551-1552 of the Legislative Journal.)

Finally, Mr. President, I have a message from the President of the United States addressed to the Clerk. (Read. See page 1552 of the Legislative Journal.)
