SPEAKER MARVEL: Hearing no objection, so ordered. One last call, does anybody have any legislation that is buried someplace that you would like to dig un? Now is your chance. Last call for any legislation.

CLERK: Mr. President. (Read title to LB 527 and 528, pages 316 and 317, Legislative Journal.)

Mr. President, Senator Kremer would like to ask unanimous consent to have his name added to LB 182 as cointroducer.

SPEAKER MARVEL: Hearing no objection, so ordered.

CLERK: Mr. President: (Read title to LB 529, page 317, Legislative Journal.)

SPEAKER MARVEL: The motion is carried. The report is approved. Now we go to the last one, Banking, Senator DeCamp.

Mr. President, your committee on Miscellaneous Subjects whose Chairman is Senator Hefner reports a series of items to the Legislature; reports LB 134 to General File, LB 490 to General File; LB 497 to General File with amendments; LB 101 Indefinitely postponed; LB 193 Indefinitely postponed; LB 368 Indefinitely postponed; and LB 430 Indefinitely postponed. All signed by Senator Hefner as Chair.

Mr. President, a new resolution, LR 38. (Read. See pages 937 and 938, Legislative Journal.) That will be laid over, Mr. President.

SPEAKER MARVEL: Motion is to advance the bill to E & R for review. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 29 ayes, 0 nays, Mr. President, on the motion to advance LB 310.

SPEAKER MARVEL: While the Legislature is in session and capable of transacting business, I am about to sign and do sign LR 66. Are we ready for 497 now?

CLERK: Yes, sir, we are. Mr. President, LB 497 (read title). The bill was read on January 20. It was referred to Miscellaneous Subjects, Mr. President. The bill was advanced to General File. There are committee amendments pending by the Miscellaneous Subjects Committee.

SPEAKER MARVEL: Senator Barrett, do you wish to handle the committee amendments to LB 497?

SENATOR BARRETT: Thank you, Mr. Speaker and members, there are two additional Miscellaneous Subjects Committee amendments to LB 497. Specifically the repeal of 72-731 which is a section to require public buildings to display the American flag day and night until the Vietnam war ends and the other is the repeal of Chapter 78 which was enacted in 1883 involving old salvage laws, salvage of boats, logs, et cetera, et cetera, regulating the finders and the salvors in what may or may not be done. Finally, it corrects a technical mistake in the bill, on page 2, lines 2 and 5. I would move that the committee amendments be adopted.

SPEAKER MARVEL: The motion is the adoption of the committee amendments to LB 497 as explained by Senator Barrett. All those in favor vote aye, opposed vote no. Record.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of the committee amendments.

SPEAKER MARVEL: Motion is carried. The committee amendments are adopted. Senator Hoagland.

SENATOR HOAGLAND: Mr. Speaker and colleagues, about a half an hour ago there was distributed a two page memo that

summarizes the various statutes that are to be repealed both in the original bill and in a set of amendments that Senator Wesely will offer. Now I don't think it makes sense to spend time going through all of these things but why don't I just mention two or three of the most interesting. The bill would repeal Section 71-504, a law that was enacted in 1919 to prohibit the use of common drinking cups. The bill would also repeal a series of about eleven sections that were enacted in 1947 and were known as the Nebraska Antifreeze Act. Now what happened is sometime after the war a bad batch of antifreeze was marketed in the State of Nebraska and as a result of that a minor regulatory scheme was enacted which requires that any new antifreeze to be marketed in Nebraska be tested by the Department of Agriculture. Now the Department of Agriculture has faithfully been doing that for many, many years now with the cost of about \$2,000 per batch of antifreeze tested. It also costs the company about \$2,000 to prepare a batch of antifreeze for testing. There has been no problem with any antifreeze marketed in the State of Nebraska since the act was passed in 1947, as I understand it, and this request for repeal comes to us from the Department of Agriculture. Now most of the statutes that are included in the original committee bill have been recommended by state agencies following a survey that my office took over the summer. The final subject that I might mention is the repeal of the public library employees retirement fund which was set up in 1921. It was designed for the City of Omaha and their retirement fund is now obsolete because Omaha treats the employees of the library like all other city employees and their retirement benefits are handled in that fashion. So the City of Omaha has consented to our repealing those provisions. I would be happy to answer any questions about any of the provisions that we are repealing in the original bill or in the committee amendments and Senator Wesely, I am sure, will want to address his amendment will be happy to answer any questions about the repealers and that he has come up with. Thank you, Mr. Speaker.

SPEAKER MARVEL: Okay, Senator Wesely, do you have an amendment you wish to propose?

SENATOR WESELY: Mr. Speaker, members of the Legislature, I do have an amendment to LB 497. It does repeal an additional five sections of the statutes or approximately five sections of the statutes dealing with a number of different items. These were brought to me by the bill drafter's office. When senator Hoagland passed his bill last year which repealed a number of statutes, I added an amendment which said that the bill drafter's office will as a matter of course in drafting legislation look for statutes that are no longer

necessary and will then recommend to the Legislature the repeal of those statutes. This amendment that I am offering then is a result of that effort by the bill drafter and, again, I would like to emphasize, this will be an ongoing effort. I know Senator Hoagland will continue his efforts but the bill drafter as well will as part of the statutes have to try and find obsolete language that we no longer need and then ask that it be repealed each session. The different sections I have deal with a number of different things. Pro!ably the one which may catch your eye more than any other is the one dealing with the sticker for the Game and Parks Commission which they can charge a dollar for to get into a state recreation area. That sounds familiar, doesn't it. Well, we are repealing that section. Don't get your hopes up. We are not repealing the park entry fee but, in fact, sometime ago we passed this other sticker law and provided for this opportunity but it never was used and never enacted and just was sitting on the books and then we passed this other one and so they are in duplication and we don't need this and it has not been used and so I think that Senator Goodrich has checked with the Game and Parks Commission Office as Senator Hoagland and others have and quite, in fact, there is no need for that section at all even though it may catch your eye. So I ask for the adoption of my amendment to this b111.

SPEAKER MARVEL: The motion is the adoption of the Wesely amendment to the bill. All those in favor of that motion vote aye, opposed vote no. While we are waiting for the vote, it is my privilege to introduce from Senator Stoney's District 72 eighth grade students and ten adults from St. Robert School, Omaha, Nebraska, Mr. Luvern Gubbels, Mr. Larry Zahm, and Mrs. Laura Gelecki are the teachers, and if you will hold up your hands, we will wish you good morning. Where are you located? From Senator Goll's District, 58 fourth grade students and six adults from Central School of Blair, Nebraska. Mrs. Mabel Kastrup and Mrs. Mary Sellon are the teachers and they are in the South balcony and will you raise your hand so we can see where you are. We are still voting on the Wesely amendment to the bill. Record.

CLERK: 25 ayes, 0 nays, Mr. President, on the motion to adopt the Wesely amendment.

SPEAKER MARVEL: The amendment is adopted. Senator Hoagland.

SENATOR HOAGLAND: Let me just say a couple of remarks in closing, Mr. Speaker. With the bill now as amended, we will be repealing about between sixty and seventy sections of the Nebraska statutes that are obsolete, about fifteen or twenty

pages of the Nebraska code, and we are also by getting rid of the Nebraska Antifreeze Act being able to get rid of some Nebraska...some excessive governmental regulation, not a lot of regulation, granted, but at least we are undoing that particular regulatory scheme. So I would ask your advancement of this particular bill. Thank you.

SPEAKER MARVEL: The motion is to advance the bill as amended. All those in favor of that motion vote aye, opposed vote no. LB 497. Have you all voted? Record.

CLERK: 25 ayes, 0 nays, Mr. President, on the motion to advance the bill.

SPEAKER MARVEL: The motion is carried. The bill is advanced. LB 250.

CLERK: Mr. President, LB 250 (read title). The bill was read on January 16, referred to Government, Military and Veterans Affairs, advanced to General File. There are committee amendments pending, Mr. President.

SPEAKER MARVEL: Senator Kahle.

SENATOR KAHLE: Mr. Speaker and members, the committee amendments involve a couple of words really. LB 250 makes several changes relating to the Commission for the Hearing Impaired. Most of the bill involves technical changes but the committee did make three changes to the bill. First on page 3, we reinserted that the Commission was for "advocating" public policies and programs rather than "facilitating" them. We felt that "advocating" better defined their mission. Secondly, on page 4 we again reinstated language, this time "promote" the training of interpreters rather than the Commission would "provide" for their training. Providing for the training of interpreters could have a major fiscal impact on the Commission and the Commission does not want to get into this area. Finally on page 4, we reinserted the word "voluntary" to say that the Commission will conduct a voluntary census of the hearing impaired people of the state rather than just a census. The committee felt this could create a situation of forced registration by people that they are hearing impaired and no one wants to force this. These are the committee amendments. I move for their adoption.

SPEAKER MARVEL: The motion is the adoption of the committee amendments. All those in favor of that motion vote aye, opposed vote no. Record the vote.

CLERK: Mr. President, Senators Fowler and Johnson move pursuant to Rule 6, Section 14 to override the Governor's line item veto of the Department of Roads Program #305 - Assistance to Local Transit Authorities found in Section 13 on page 14 of the bill.

SPEAKER MARVEL: Senator Fowler.

SENATOR FOWLER: I would like to pass over that and get to some bigger ones first.

SPEAKER MARVEL: Is that your request?

SENATOR FOWLER: Yes, I would request that we pass over that temporarily.

SPEAKER MARVEL: Is there an objection? Hearing no objection, we go to the next item.

CLERK: Mr. President, the next motion is from Senator Koch. Senator Koch would move pursuant to Rule 6, Section 14 that the Legislature override the Governor's line item veto of the State Department of Education, program Number 143, State Aid and School Food Service and Reserve Teacher Act contained in subdivisions (b) and (c) of subsection (l) of Section 5 found on pages 3 and 4 of LB 561.

SPEAKER MARVEL: The Chair recognizes Senator Koch.
