CLERK: Mr. President, LB 589 offered by the Banking Committee and signed by its members. (Read title). The bill was read on January 6 of this year. It was referred to the Banking Committee for public hearing. The bill was advanced to General File, Mr. President.

PRESIDENT: The Chair recognizes Senator DeCamp.

SENATOR DeCAMP: Mr. President and members of the Legislature, last year the Legislature completely rewrote the limited partnership laws. The last time it had been done was 1916. When we did it, taking the advice...and I am not going to take the blame, taking the advice of some professors from different universities, we left out some things that had been put in in 1971 and '77. They were technical things and, quite frankly, quite minor, but they screwed up the operation of a couple of limited partnerships that were in existence and so we are re-instating that language and that is what this amounts to. It is a technical correction of the thing we left out last year and it is agreed to by everybody. The people that drafted the new law, the uniform law, agreed that these probably should have been left in, so what they have to do with, keeping records, for example, you don't have to keep physical records in the State of Nebraska if the limited partnership base is outside of the state, some things like that. I would move advancement.

I want you to know I wholeheartedly support your bill. The bill does have a fiscal note of \$6 million. I assume that is money that we traditionally appropriate to this function in any event. In any event at what level the Legislature will then determine that with or without the commission there would be some expenditures for maintenance of buildings in the capital construction and that is the appropriate place for the Legislature to consider it. So the amendment strikes the \$6 million and retains only the administrative cost to the agency.

SENATOR CLARK: The question is the adoption of the committee amendments. All those in favor vote aye, opposed vote nay.

CLERK: Senator Clark voting yes.

SENATOR CLARK: Record the vote.

CLERK: 28 ayes, 0 nays, Mr. President, on adoption of the committee amendments.

PRESIDENT: Thank you Senator Lamb. Before we get started the Chair also would like to introduce some guests of Senator Marsh, 28 students, eighth grade students from Lincoln Christian School, Levi Kroeker their teacher. They are up here in the north balcony. Would they be recognized. Welcome to your Unicameral Legislature, Lincoln Christian. I guess we are ready then Mr. Clerk for agenda item number four, Final Reading. Sergeant at Arms will secure the Chamber. All non-authorized personnel will leave the floor at this time. CLERK: Mr. President, if I may right before that I have got four Attorney General opinion's to be inserted in the Journal.

PRESIDENT: All right, go ahead.

CLERK: Mr. President, Senator Warner would move to return LB 604A for a specific amendment. The Warner amendment is found on page 1304 of the Legislative Journal. That is 1304.

PRESIDENT: The Chair recognizes Senator Warner.

SENATOR WARNER: Mr. President, members of the Legislature, the amendment is to reduce the amount of the A bill for the operations of what we refer to as the 309 committee from or task force from \$300,000 to \$150,000. You may recall that when the bill was advanced to the floor there was a committee amendment that reduced, as introduced the A bill carried an appropriation for maintenance work at the level of six million and it was reduced to one million which is what is allowed for in the budget. It is in the budget bill but the operating cost was based upon that larger amount, \$150,000 continues the agency at the same level that it is currently being funded, actually a little less than what it is currently being funded but adequate to continue the responsibilities that they will have. I move the bill be returned to adopt the amendment to strike \$300,000 and put \$150,000 back in it.

PRESIDENT: Chair recognizes Senator Newell.

SENATOR NEWELL: Mr. President, I want to ask Senator Warner a question.

PRESIDENT: Senator Warner, will you respond?

SENATOR NEWELL: Senator Warner, this cuts it again from \$350,000 to \$150,000 for administrative costs for the 309 Commission?

SENATOR WARNER: No, let me rephrase so it is clear. The \$300,000 was appropriate had six million been appropriated for the actual work. There is only one million. The \$150,000 continues the agency at the same level, actually about \$20,000 less I think than what the agency currently has for operating costs. It is adequate to maintain the agency at a continuation level only for administrative costs.

SENATOR NEWELL: Let me ask you this question. Why does it cost less, if you are going to do the same reviews assess the same projects, determine...try to prioritize them, why does it cost less in administrative costs if there is less money to be appropriated? You don't have to look as deep? Or as long at the various projects or...

SENATOR WARNER: Part...last year you may recall Senator Newell that I think the appropriation for the agency was around \$220,000, but about between \$50,000 and \$60,000 of that was for that computer, putting on computer all of the state owned facilities and the work associated with the 309 Task Force. That has been completed and part of that purpose of course was to reduce some of their operating costs that they otherwise had. So the savings from the computer actually permits to slightly reduce the amount this year and still maintain their same effectiveness.

SENATOR NEWELL: You say this is not an opportunity for me to add more money to the preventative maintenance program. Is that correct?

SENATOR WARNER: The amendment we just offered is not the place to do it. You certainly could do that in that A bill or 761 or any other A bill if you like.

SENATOR NEWELL: Thank you Senator Warner. Thank you.

PRESIDENT: Any further discussion on the Warner amendment to 604A? It is a motion to return. Seeing no further... there is no further discussion Senator Warner, would you have any closing? Motion then is the return of LB 604A for the specific Warner amendment. All those in favor vote aye, opposed vote nay. Record the vote.

CLERK: 40 ayes, 0 nays Mr. President on the motion to return the bill. Motion carries, LB 604A is returned. Senator Warner, do you wish to make your move to adopt your amendment.

SENATOR CLARK: Have you all voted? Record the vote.

CLERK: (Read record vote. See pages 1925 and 1926, Legislative Journal.) 47 ayes, 0 nays, Mr. President, 2 excused and not voting.

SENATOR CLARK: The bill is declared passed on Final Reading. LB 609A.

ASSISTANT CLERK: (Commenced reading of LB 609A.)

SENATOR CLARK: Pardon me, Senator Fowler, for what reason to you rise?

SENATOR FOWLER: I guess this is just a procedural question and it is as good a bill to clear it up on as any. The

I mean a roll call vote.

SENATOR CLARK: (Interruption) a record vote and a roll call vote.
