SENATOR CLARK: No objections? So ordered. We will now take up 314.

CLERK: Mr. President, LB 314 introduced by Senator Higgins. (Read title.) The bill was read on January 19 last year. It was referred to the Public Health and Welfare Committee. The bill was advanced to General File. There are committee arendments attached, Mr. President.

SPEAKER MARVEL: Senator Cullan.

CLERK: Mr. President, LB 605 offered by Senator Koch. (Read title.) The bill was read on January 6. of this year. It was referred to the Miscellaneous Subjects Committee for hearing. The bill was advanced to General File, Mr. President. I have no amendments to the bill.

SPEAKER MARVEL: The Chair recognizes Senator Koch.

SENATOR KOCH: Thank you, Mr. Speaker. 605 does several things and I will try to highlight them for you. One, it requires a person to renew his license or her license by July 1 each year instead of allowing two years as we presently do from the date of expiration. A number of license holders are now only renewing every other year. Secondly, it would prohibit a person from lending his or her license or knowingly permit the use thereby to another person and this is now happening because the present statute does not prohibit the practice. Thirdly, it requires the payment of a delinquent fee by any individual failing to file a proper application with fees for inspection of electrical installation as required by statute. At the present time charges must be filed by the county attorney against the individual resulting in a lengthy time and an expense consuming delays. At the present time also there are people who repeatedly will not file the application for an inspection and pay the fees unless they are actually caught making the inspection by a state electrical inspector. So that is the reason for the delinquent fee that is being suggested to reduce the number of offenders that are presently being carried on in the State of Nebraska. I ask for the adoption on the motion to advance to E & R LB 605.

SPEAKER MARVEL: Senator Hefner.

SENATOR HEFNER: Mr. President, members of the Legislature, the Miscellaneous Subjects Committee held a hearing on this bill. We discussed it thoroughly and voted unanimously to bring it to the floor. We think there is a need for this bill and it does carry out some of the provisions that we think that we are having problems with. So, therefore, I would urge this body to move this bill on at this time.

SPEAKER MARVEL: Senator Beutler.

SENATOR BEUTLER: Just a question of Senator Koch if I may. Now, Jerry, the section in the statute that prohibits the lending of licenses, if a person to whom the license is lent uses the license, that is a criminal violation and he can be prosecuted. Is there no criminal violation as far as the person who lends the license is concerned? I guess all I am saying is I am wondering if that section is really necessary. It seems to me that that should be, if it is not, it should be covered as a criminal violation elsewhere in the criminal statutes.

SENATOR KOCH: I can't answer right now but I will get...I will try and get the answer for you, Senator Beutler. All right?

SENATOR BEUTLER: Okay, thank you.

SENATOR KOCH: Senator Goodrich says he can.

SPEAKER MARVEL: The Chair recognizes Senator Goodrich.

SENATOR GOODRICH: There is no penalty of any kind for this now and it is being done frequently, frankly.

SENATOR BEUTLER: It just seems to me that as a broad public policy question, there should be a law against the lending of any license like that. You know, I guess I am wondering why...I understand why you are doing it here, why aren't we doing it everywhere? I guess I am surprised that that act is not presently covered with regard to all licenses, doctors or lawyers or whatever.

SENATOR GOODRICH: Well, a doctor, for example, he can't even practice without having a license, for example. This deals with contractor's licenses. The contractor then hires journeymen electricians, for example, who are licensed who then perform the work. But this deals with the actual contracting itself which means that a man holds a journeyman's license and also a contractor's license can then say, okay, to this guy that is a journeyman licensed electrician, he wants to do a job. He doesn't have a contractor's license though. says you go ahead and do the job and we will put the job through my name as a licensed contractor. What we are doing ... in other words, you are getting licensed people to do the job but it is just they don't have the technical aspect of having a contractor's license besides the journeyman's license. So, consequently, that is what we are doing, we are saying they cannot loan their contractor's license, the contractor's portion of their license and, believe me, the penalty, for example, for

them to do the job without having a journeyman's license to do the job with would be severe and they have got penalties in for that but it is just this contractor's level up here and this is all this does, prohibits the contractors of loaning their license.

SPEAKER MARVEL: Senator Koch, do you wish to close?

SENATOR KOCH: I have no closing. I just move that we advance LB 605 to E & R Initial as presented.

SPEAKER MARVEL: All those in favor of that motion vote aye, opposed vote no. Record the vote.

What the bill does is broadens the ability of the state to collect on delinquent accounts from governmental subdivisions where...by withholding of state aid funds with the procedures spelled out in a time frame that has to elapse in order to do it. It is a procedure we already have in one case in the Department of Institutions where this would broaden and keep those bills current. The process is one where if it is an account in excess of \$1,000 over 60 days old the director of the agency that is involved would notify the Department of Administrative Services of that fact which the Department of Administrative Services Director would then notify the governmental subdivision involved that they had 30 days to do that, to pay the bill, or else the law would be used to withhold from their next state aid payment, whatever, from the general fund portion, whatever amount that was necessary to pay the bill and at the end of the 30 days if it was not collected, then the treasurer would be notified who again would check to make sure whether or not the local entity had paid it, and if they had not, would proceed to withhold an amount equal to the amount of the bill from the state aid payment, and it probably

However, one of the political subdivisions in the State of Nebraska is interpreting it, which frankly it is Omaha, is interpreting it that if a Class A journeyman does a lesser grade of work that they can require him to come in and get that grade of license also. So what we are saying is, what the original intent of the law was and that is if you got the top grade of license you can do everything that is called for in lesser grades of license. We are just clearing up the point so that they not only don't have to pay the fee, because that is already in the law, but it is just that they don't have to take the examination for lesser grades of license to do the lesser grades of work, if they got the top license. Thank you. I move the adoption of the amendment.

Mr. President, Senator Newell would now move to return LB 757 to Select File for a specific amendment, that amendment being to eliminate the State Board of Equalization's authority to set the sales and income tax rates.

PRESIDENT: The Chair recognizes Senator Newell.

SENATOR NEWELL: I won't speak long if I could have some silence. Thank you, that's not a bad deal. The proposal that I am offering this Legislature is one of those that you might call a...to use a colloquialism, a "fess up" amendment, and that is simply that it will strike the State Board of Equalization's Authority to set sales and income tax rates. We would have to bring 757 back one more time to set the income tax rate after this amendment is passed but I don't think that is any great problem. I think then we have a philosophically reasonable way of explaining this to the public. We can take this out of all of the politics and so forth and have the Legislature do what 49 other states do and that is set the sales and income tax rates. I think it would be very responsible. It would help the public understand just exactly who creates the problem. It is not only the Legislature, it is also the Executive, but at least places that authority between the Legislature and the Executive Branch and not solely in the Executive Branch. That way we won't have these kinds of election year situations when we have a real fiscal crisis. I would hope this body would accept this amendment. It is the right and philosophically correct thing to do.

PRESIDENT: The Chair recognizes Senator Hefner. Okay. The Chair recognizes Senator Burrows.

SENATOR BURROWS: Mr. Chairman, I support the Newell amendment. I think the situation over the last year and the failure
