SPEAKER MARVEL PRESIDING

DR. PALMER: Prayer offered.

SPEAKER MARVEL: Roll call. Please record your presence. Record.

CLERK: There is a quorum present, Mr. President.

SPEAKER MARVEL: Do you have anything under item #3?

CLERK: Yes, sir, Mr. President, your committee on Administrative Rules and Regulations gives notice of hearing for Wednesday, January 20.

Mr. President, your committee on Business and Labor gives notice of hearing for January 20, 27 and February 3 and that is signed by Senator Barrett and Senator Johnson.

Mr. President, I have two Attorney General's opinions, one addressed to Senator Labedz regarding LB 138 and one addressed to Senator Fowler regarding LB 231. (See pages 280-282 of the Legislative Journal.)

Mr. President, Senator DeCamp would like to print amendments to LB 622 or 233. (See pages 282-283 of the Journal.)

Mr. President, I have received two reports from the Middle Republic NRD and the Lower Platte South NRD regarding payment of attorney fees. (See pages 283-284 of the Legislative Journal.)

I will have on file in my office a report I received from the Director of State Engineer Department of Roads pursuant to LB 722.

Mr. President, new bills: (Read by title for the first time LB 825-833 as found on pages 284-286 of the Legislative Journal.)

SPEAKER MARVEL: We are ready for item #5, Final Reading, and the Chair recognizes Senator Vard Johnson.

CLERK: Mr. President, Senator Johnson would move to suspend Rule 6, Section 7(b) to permit the Final Reading of LB 664 today.

SENATOR V. JOHNSON: Mr. Speaker, members of the body, I want to thank you for your indulgence with this particular measure. As you know this is the bill that would name the gymnasium for the Nebraska School for the Deaf after Mr. Nick Peterson who is an alumnus of the Nebraska School for

whose Chairman is Senator Cullan, reports LB 606 to General File and LB 829 to General File, both signed by Senator Cullan as Chair.

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Senator Kahle.

SENATOR KAHLE: Mr. Speaker....

SPEAKER MARVEL: 198.

SENATOR KAHLE: Senator Warner had Indicated the other day that he had an amendment for 198, and his office called this morning, he is not here, of course, today, and he wants to rewrite that amendment, so I ask that we pass over 198 for the present time.

SPEAKER MARVEL: Any objections? This goes to the passover file. Ckay, next, LB 274.

CLERK: Mr. President, there are E & R amendments on 274.

SPEAKER MARVEL: We are adopting E & R amendments to 274. The Chair recognizes Senator Chambers.

SENATOR CHAMBERS: Mr. Chairman, I move that the E & R amendments to LB 274 be adopted.

SPEAKER MARVEL: All those in favor of that motion say aye. Opposed no. The motion is carried. The E & R amendments are adopted.

CLERK: Mr. President, I now have an amendment offered by Senator Sieck that is found on page 392 of the Legislative Journal.

SPEAKER MARVEL: The Chair recognizes Senator Sicck.

SENATOR SIECK: Mr. President and members of the body, I do have an amendment here but Senator Remmers also has an amendment on the same subject and I feel his amendment covers the issue better than the one that I submitted, so I will ask that mine be withdrawn and that we consider Senator Remmers' amendment.

SPEAKER MARVEL: Okay, hearing no objections, so ordered. The amendment is withdrawn.

CLERK: Mr. President, Senator Remmers would now move

for a period of three years. Is that your interpretation?

SENATOR KOCH: No.

SENATUR V. JOHNSON: The reason I say that is because it says...the bill says, it shall then consider the appointment and contracting for a Commissioner of Education whose appointment may be for a period of three years. Now the "may" would indicate that it is permissive.

SENATOR KOCH: That's right.

SENATOR V. JOHNSON: But if they do a contract, then you are saying it can be for any period of time up to three years.

SENATOR KOCH: Up to three years.

SENATOR V. JOHNSON: All right.

SENATOR KOCH: It could be annual, biennial or three.

SENATOR V. JOHNSON: Okay, thank you very much.

SENATOR CLARK: Any further discussion? Is there any closing, Senator Koch? The question before the House is the advancement of 654 to E & R. All those in favor vote aye, opposed vote nay. Record the vote.

CLERK: 33 ayes, 0 mays on the motion to advance the bill. Mr. President.

SENATOR CLARK: The bill is advanced? Is Senator Kremer here?

CLERK: No. he is excused.

SENATOR CLARK: We had better skip over the next bill then. We will take up 829.

CLERK: Mr. President, LB 829 is a bill introduced by the Public Health Committee. (Read title). The bill was read on January 14, referred to Public Health for hearing. The bill was advanced to General File, Mr. President.

SENATOR CLARK: Senator Cullan.

SENATOR CULLAN: Mr. President and members of the Legislature,

what this bill does is eliminate the Advisory Council on Hospital and Medical Care Facilities. Now this is simply a bill to eliminate this council which has not been functioning for several years. In fact, the testimony from Dr. Smith of the Department of Health indicates that the membership of this particular council is not even...it would be impossible to even locate some of them now. Some of them are deceased. They have not kept the membership of this Advisory Council current, and most of their functions are now gone. But the functions of the Advisory Council on Hospital and Medical Facilities were related to the Hill-Burton Program which, of course, has long since been eliminated. And so the Department of Health saw no reason to continue the operation of this particular advisory body. With that, I would urge you to advance LB 829.

SENATOR CLARK: Is there any discussion? If not, that is your closing. Do you want to advance the bill? To E & R, 829. All those in favor vote aye, opposed vote nay.

CLERK: Senator Clark voting yes.

SENATOR CLARK: Record the vote.

CLERK: 30 ayes, 0 mays on the motion to advance the bill, Mr. President.

SENATOR CLARK: The bill is advanced. We will take up the next one which is a noncontroversial bill, LB 623.

CLERK: Mr. President, LB 623 was a bill introduced by Senator John DeCamp. (Read title). The bill was read on January 6 of this year. It was referred to the Banking, Commerce and Insurance Committee for public hearing. The bill was advanced to General File, Mr. President. There are committee amendments pending.

SENATOR CLARK: Committee amendments. Senator Cullan, for what purpose do you rise?

SENATOR CULLAN: I was inquiring as to why you passed over LB 606. Senator Kremer asked me to handle that bill for him since he was absent and I would be happy to handle LB 606.

SENATOR CLARK: All right, we will come back to 606. Senator De Camp.

SENATOR DeCAMP: Mr. President and members of the Legislature,

Mr. President, your committee on Enrollment and Review respectfully reports they have carefully examined and reviewed LB 654 and recommend that same be placed on Select File; 829 Select File with amendments, both signed by Senator Kilgarin.

Mr. President, Senator DeCamp asks unanimous consent to add his name to LB 824 as cointroducer.

SPEAKER MARVEL: No objection, so ordered. It is my privilege to introduce in the North balcony students from Omaha South High School with their teacher, Sally Fellows. Will you please hold up your hand so we can see where you are? The Senator is Karen Kilgarin. We are ready for item #4, motions.

CLERK: Mr. President, Senator Kahle pursuant to our rules moves to place LB 635 on General File notwithstanding the action of the Public Health and Welfare Committee. Senator Kahle's motion is found on page 486 of the Journal.

SPEAKER MARVEL: Senator Kahle, the Chair recognizes you.

SENATOR KAHLE: Mr. Speaker, members of this august body, we never know what is going to happen on Monday mornings and Friday afternoons so I am not sure that this is a good time to try this or not but I am attempting to bring LB 635 to the floor notwithstanding the action of the Public Health and Welfare Committee. This is the same bill that I introduced last year, last session, as LB 107 and the

SENATOR CLARK: Senator Kilgarin.

SENATOR KILGARIN: I move the E & R amendments to LB 728.

SENATOR CLARK: You have heard the motion. All those in favor say aye. Opposed. The amendments are adopted. Anything further?

ASSISTANT CLERK: I have nothing further on the bill.

SENATOR CLARK: Senator Kilgarin.

SENATOR KILGARIN: I move we advance LB 728.

SENATOR CLARK: You have heard the motion. All those in favor say aye. Opposed. The bill is advanced. LB 654.

ASSISTANT CLERK: Mr. President, I have no E & R amendments. I have nothing else on the bill.

SENATOR CLARK: Senator Kilgarin.

SENATOR KILGARIN: I move we advance LB 654.

SENATOR CLARK: The motion is to advance LB 654. All those in favor say aye. Opposed. The bill is advanced. LB 829.

ASSISTANT CLERK: There are E & R amendments, Mr. President.

SENATOR KILGARIN: I move the E & R amendments to LB 829.

SENATOR CLARK: You have heard the motion. All those in favor say aye. Opposed. The E & R amendments are adopted. Anything further on the bill?

SENATOR CLARK: You have heard the motion. All those in favor say aye. Opposed. The bill is advanced. LB 703.

ASSISTANT CLERK: Mr. President, there are E & R amendments.

SENATOR CLARK: Senator Kilgarin.
