PRESIDENT: The resolutions are next.

CLERK: Yes, sir.

PRESIDENT: We have about five resolutions, I am told. All right, Mr. Clerk, read the first....

CLERK: Mr. President, Senator Lamb would move to approve the revenue bond related expenditures to state colleges pursuant to Section 85-480 of the Nebraska Revised Statutes.

PRESIDENT: The Chair recognizes Senator Lamb. Senator Lamb, this is on the state colleges for a former report.

SENATOR LAMB: I believe we will just pass over that.

PRESIDENT: All right, you don't want to take it up today? Not until next year, huh? Okay. Go to the next one, Mr. Clerk.

CLERK: Mr. President, the next thing I have is a resolution from Senator Higgins. Senator Higgins, who has just left the Chamber...oh, is returning. Mr. President....

PRESIDENT: Do you want to read the resolution?

CLERK: Yes, sir, I do.

PRESIDENT: Tell us where it is.

CLERK: Mr. President, Senator Higgins and Labeledz offer the following resolution: (Read resolution.)

PRESIDENT: All right, just a moment. Let's get some order. It is very difficult to hear. Would you please, please, let's listen because we only have a few resolutions. Let's get them out of the way and then we will be ready to wind it up as I said before. Senator Higgins, now can you hear? All right.

SENATOR HIGGINS: Thank you, Mr. Speaker.

PRESIDENT: Senator Higgins. Anything further? Senator Marsh, did you wish to address this resolution?

SENATOR MARSH: Mr. President and members of the Legislature, I think each of us has a warm spot in our heart for this new American and we are very pleased and very proud to welcome Nga DeCamp as the newest member of our legislative family. With great pleasure I look forward to voting for this.

PRESIDENT: All right. So the question then is the adoption of the Higgins-Labedz resolution. All those in favor vote aye, opposed nay. Okay, record the vote.

PRESIDENT: All right, motion carries. The resolution is adopted. Next resolution.

CLERK: Mr. President, LR 192 by Senator Rumery. It is found on page 2358. (Read LR 192.)

PRESIDENT: Senator Rumery.

SENATOR RUMERY: Mr. President and members of the Legislature, I am anxious that the Legislature recognize Dr. Virgil Johnson for his scientific pursuits, particularly in the breeding of wheat. He has at this time made substantial improvements in 21 different varieties of wheat and many of them are now grown in various parts of the world. Also he has been able to raise the protein content of some of the wheat varieties that he has developed so it certainly is helping the poor people all around the world. I move that we adopt the resolution.

PRESIDENT: Any further discussion? Okay, Senator Rumery, I guess that is your opening and your closing. The question is the adoption of LR 192. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 41 ayes, 0 nays on adoption of the resolution, Mr. President.
