SPEAKER MARVEL: All in favor of that motion say aye, opposed no. The motion is carried. The bill is advanced. Do you have anything else on the desk, Mr. Clerk?

CLERK: Yes, sir, I have several things to read.

Mr. President, first of all, a new A bill, LB 197A. (Read title.)

Mr. President, a new resolution, LR 20. (Read) That will be laid over, Mr. President.

Mr. President, Senator Wesely would like to have his name added to LB 34 as cointroducer.

Mr. President, Senator Burrows wants to remind the body that the tour of the Beatrice State Developmental Center is for tonight. Vans will leave the west door at 4:00 p.m. today for those planning to attend. Please let Senator Burrows' office know if you plan on going.

Mr. President, I have Committee on Committees confirmation reports from the Miscellaneous Subjects Committee and the Constitutional Revision and Recreation Committee.

PRESIDENT: Have you all registered your presence?

CLERK: Mr. President, Senator Labedz would like to be excused until she arrives.

PRESIDENT: Record the presence. Mr. Clerk.

CLERK: Quorum present. Mr. President.

PRESIDENT: Quorum being present, any corrections to the Journal?

He just passed away a little over a week ago but his accomplishments are many. Some of these are: He served churches at Hickman, Filley, Lincoln Heights, Arlington, Syracuse, Wymore, Cozad, Norfolk, McCook, Omaha, this was at the Trinity Methodist Church, Exeter and Milligan. He served as a public relations director at Nebraska Wesleyan University. He was a former state Capitol tour guide and he was a avid admirer of this building. During the bicentennial celebration he presented slide presentations to show the public the many beauties of this building. He did very much for the youth of Nebraska. He was the founder of the Nebraska Committee for Children and Youth. He was the founder of the Methodist Camp at Cozad, better known as Camp Comeca, While he served at Exeter he was instrumental in getting coveted award for that community in the community improvement program for that town of its size. He was one of the oldest persons to ever have open heart surgery and after he recovered he would counsel people that would be going for this major operation that if he withstood the operation they should be able to too and I think he was a hope for many people that had to undergo open heart surgery.
