SPEAKER MARVEL: Senator Wiitala.

SENATOR WIITALA: I would just like to clarify some of the processes that the bill addresses. One of my main concerns was, what redress did the public have that they favored or disfavored, the enactment of such a project. I just want the body to understand that such a project is initiated by the landowners or the property owners that are involved and there are provisions there that if 51% of those landowners agree with that project that it can be terminated. In answer to Senator Nichol's question on whether it could be a recreational project, I suppose it probably could be but again, it would be by the vote, it would be by the initiative of those property owners that were involved and I doubt whether the right of eminent domain would probably be used in this as it pertains to this bill.

SPEAKER MARVEL: The motion is the advancement of LB 388 to E & R for review. All those in favor vote aye, opposed vote no. Record.

CLERK: 26 ayes, 1 nay, Mr. President, on the motion to advance the bill.

SPEAKER MARVEL: The bill is advanced. Do you have anything to read in before we adjourn?

CLERK: One brief item, Mr. President. LR 25 by Senator Kilgarin. (Read title.) Mr. President, that will be laid over pursuant to our rules. (See pages 670-671 of the Legislative Journal.) That is all I have.

SPEAKER MARVEL: Senator Marsh, do you want to adjourn us until tomorrow morning at nine?

SENATOR MARSH: Mr. Speaker, I move we adjourn until nine o'clock tomorrow morning, February 26.

SPEAKER MARVEL: All those in favor of that motion say aye, opposed no. The motion is carried. We are adjourned until tomorrow at 9:00 a.m.

LR 24? Seeing none, Senator Goodrich, will you close?

SENATOR GOODRICH: Can't we just vote on the thing and be done with it.

PRESIDENT: The motion is the adoption of Legislative Resolution 24. All those in favor vote aye, opposed nay. Clerk, record the vote.

CLERK: 28 ayes, 5 mays on the adoption of the resolution, Mr. President.

PRESIDENT: Motion carries. Legislative Resolution 24 is adopted. We will proceed then with Legislative Resolution 25.

CLERK: Mr. President, LR 25, found on page 670 of the Journal is offered by Senator Kilgarin. (Read.)

PRESIDENT: The Chair recognizes Senator Kilgarin,

SENATOR KILGARIN: Thank you. Mr. President and members of the Legislature, LR 25 is a simple noncontroversial resolution that will honor our social workers. There are over four hundred professional social workers in the State of Nebraska. They live and they work here. We have recognized their contributions through establishing graduate and undergraduate programs in our educational institutions who confer degrees upon these people and with LR 25 we would be acknowledging their contribution to our society. Many times this is a contribution that I feel is overlooked but certainly should not be overlooked. If just one person somewhere is helped by these social workers or a social worker, I think it is a contribution that should be recognized and I urge your support of LR 25. Thank you.

PRESIDENT: The Chair recognizes Senator Nichol.

SENATOR NICHOL: Mr. Chairman and members of the Legislature, Senator Kilgarin, are we going to give them doctors' degrees, too? I have a little hesitation seriously about this, not because I don't like social workers but what about everybody else that works for the State of Nebraska? What about every other person who is governmentally employed? What about the teachers? What about the retired teachers? I wonder why and perhaps you would like to cover this in your closing as to why you singled out one section of workers to honor. Thank you.

PRESIDENT: The Chair recognizes Senator Marsh.
