SENATOR LANDIS: Mr. Speaker and members of the Legislature,

CLERK: Mr. President, Senator Vard Johnson, Beyer, Fenger and Chronister would like to be excused for the day. Senator Kilgarin, Hoagland, Chambers until they arrive.

PRESIDENT: Record the presence, Mr. Clerk.

CLERK: There is a quorum present, Mr. President.

PRESIDENT: A quorum being present, are there any corrections to the Journal?

CLERK: The Journal is all right, Mr. President.

PRESIDENT: The Journal stands correct as published. Any messages, reports or announcements?

CLERK: Mr. President, your committee on Enrollment and Review respectfully reports they have carefully examined LB 531 and recommend that same be placed on Select File; 291 Select File; 311 Select File; 111 Select File with amendments, (Signed) Senator Kilgarin, Chair. (See pages 1158-1159 of the Legislative Journal.)

Mr. President, your committee on Business and Labor reports LB 394 to General File with amendments, 410 General File with amendments, 470 General File with amendments, (Signed) Senator Maresh, Chairman. (See pages 1159-1160 of the Journal.)

Your committee on Judiciary reports LB 512 to General File with amendments, (Signed) Senator Nichol, Chair.

Mr. President, I have a Lobby Registration report for March 12 through March 26, signed by...on file in my office.

PRESIDENT: All right then, we will proceed then with agenda item #4, a resolution on LR 47, Mr. Clerk. Will you read it.

CLERK: (Read LR 47.) Mr. President, the resolution is found on page 1126. Senator Vickers would like to amend

the resolution by adding after the word "Nebraska" the word "school" in the third paragraph.

PRESIDENT: All right so do you want to take up the amendment, Senator Vickers? You want to amend the resolution. The Chair recognizes Senator Vickers for the purpose of the amendment.

SENATOR VICKERS: Thank you, Mr. President. Mr. President and members, the resolution was drafted with a mistake in it that I did not catch and neither did the colleagues of mine undoubtedly that signed it and I am sorry about that but the resolution or the amendment that I am offering inserts the word "school" after the word "Nebraska" on the resolution. Whereas it indicates Mr. Crandall was a former teacher and superintendent at the University of Nebraska of Agriculture as reads in the resolution. In actuality he was a superintendent at the University of Nebraska School of Agriculture which was the old high school at Curtis, Nebraska, administered by the University at one time back in the past, the high school that I attended as a matter of fact, and Mr. Crandall was one of my teachers. I would ask the body to amend the resolution so that it would read correctly.

PRESIDENT: Any further discussion on the amendment to LR 47? If not, the question will be the adoption of the Vickers amendment to LR 47. All those in favor vote aye, opposed nay. Record the vote, Mr. Clerk.

CLERK: 28 ayes, 0 nays, Mr. President, on the adoption of the amendment.

PRESIDENT: Motion carries. The amendment is adopted. We are now ready for the resolution, Senator Vickers.

SENATOR VICKERS: Mr. Chairman, members, this resolution is to honor a former senator from my area, a former member of this body who also was a close friend of mine, having been one of the teachers that taught me back an eon ago when I was in high school. Mr. Crandall was an influence on all of those that knew him and an influential member of his community and obviously the entire state. He recently passed away and I would urge this body's adoption of this resolution to honor him in his memory and to send a copy of this resolution to his family expressing our gratitude for the great works that he did do for his community and the State of Nebraska. Thank you, Mr. President.

PRESIDENT: The Chair recognizes Senator Rumery.

SENATOR RUMERY: Mr. President and members of the Legislature, I want to second everything that Senator Vickers has said about former Senator Horace Crandall. It was my good fortune to know him over many years as we were working in our various fields. He was a man of great honor and stature in all of the facets in which he worked and lived. I would urge you to support this amendment.

PRESIDENT: Any further discussion then on LR 47? Hearing none, Senator Vickers, will you have any closing? No closing, the question then is the adoption of LR 47. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 33 ayes, 0 nays on the adoption of the resolution, Mr. President.

PRESIDENT: Motion carries and LR 47 is adopted. We are then ready, Mr. Clerk, for consent calendar, agenda item #5. As most of you understand, consent calendar allows the bills that are named in the order by the Speaker to be taken up for fifteen minutes only at the end of which time if you have not brought the matter to a vote and the introducer is not closing, the matter will be just left on General File as is. It just ends and you go on to the next bill at the end of the fifteen minute period. So that is assuming that the introducer is not closing. Pursuant to the rules on consent calendar we have eight bills which have been removed from consent calendar and I would like to give those to you at this time, there are nine bills. LB 492, if you will just look at your consent calendar sheet I will go over them slowly enough so that you can mark a line through them. The first one that has been stricken either by the introducer or any three members of the Legislature who object to the bill being considered on consent calendar, here they are. LB 492, LB 460 which is the next one, LB 309, LB 424, LB 326, LB 202, LB 253, LB 215, LB 99 and then turn over the sheet to LB 466 on the other side. That makes ten bills that have been removed pursuant to the rule on consent calendar. We will then proceed, Mr. Clerk, with the first bill on consent calendar which is LB 329.

CLERK: Mr. President, LB 329 was introduced by Senator Marge Higgins. (Read.) The bill was read on January 19 and referred to the Banking, Commerce and Insurance Committee. It was advanced to General File. I have no amendments on the bill, Mr. President.

PRESIDENT: The Chair recognizes Senator Higgins.

SENATOR HIGGINS: Mr. President and senators, this bill was introduced merely to bring into compliance under LB 877

Mr. President, finally, LR 47 is ready for your signature.

PRESIDENT: While the Legislature is in session and capable of doing business, I propose to sign and I do sign LR 47. Before we get started on agenda item #4, the Chair takes pleasure in introducing Senator Howard Peterson's brother from Olympia, Washington, Arthur W. Peterson. Would Art come forward and be recognized? Welcome to the Nebraska Unicameral. We also have a guest of Senator Lamb, Mr. and Mrs. Clifford Armstrong from Broken Bow. They are the parents of Rod Armstrong who is on Senator Fowler's staff. Would the Armstrongs step forward? They are under the North balcony. Good morning and welcome to the Unicameral. We will proceed then with agenda item #4, gubernatorial
