SENATOR CLARK PRESIDING

SENATOR CLARK: Have you all registered in please. Will everyone check in please. Record.

CLERK: Quorum present, Mr. President.

SENATOR CLARK: We are going to go to number seven. Clerk has some things to read in.

CLERK: Mr. President, new Resolutions, LR 51. Read LR 51. Read LR 52. Read LR 53. All three resolutions were laid over.

Senator DeCamp would like to print amendments to 284. Senator Schmitt to 331. Senator Marsh to 179 and Senator Landis to 366.

SENATOR CLARK: LB 296.

CLERK: Mr. President, LB 296 was introduced by Senator Ron Cope of the 36th District. Read title of bill. The bill was originally read on January 19th, referred to Public Health and Welfare. The bill was advanced to General File. There are committee amendments pending by the Public Health and Welfare Committee Mr. President.

SENATOR CLARK: Senator Cullan, committee amendments.

SENATOR CULLAN: Mr. President and members of the legislature, I would ask for your attention briefly as we review the committee amendments to LB 296. Let me say initially before I get into the committee amendments that Senator Ron Cope from Kearney again has brought to the Legislature, I think, a very important issue in LB 296. He has....it has been his record in the past several years making another strong effort to do what he can to effect the safety and welfare of the citizens of the State of Nebraska. I commend him for bringing LB 296 to us and for presenting the solution, hopefully, to a problem that we have had in the State of Nebraska in recent times as far as so many people dying in fires, very tragic fires in the State of Nebraska. Senator Cope will explain LB 296 to you in detail in a few minutes. I will tell you that I support it and the members of the Public Health and Welfare Committee support the concept of requiring smoke detecting devices in various facilities throughout the State of Nebraska and we would

Labeledz, do you wish to speak to it?

SENATOR LABEDZ: Thank you, Mr. Speaker.

PRESIDENT: Yes, Senator Labeledz.

SENATOR LABEDZ: Thank you. The resolution introduced by Senator Marvel and myself, and I would like to in addition to Senator Marvel's remarks add a few others. The exclusive state jurisdiction of the Fort Robinson Wood Reserve was given up in 1887 when the Wood Reserve as a part of the Fort Robinson Military Reservation was deeded to the United States. Governor Thone has been asked on behalf of the State of Nebraska to accept the relinquishment of exclusive federal jurisdiction over the Fort Robinson Wood Reserve. He has also been asked that this resolution be introduced on his behalf and adopted so that he may accept the relinquishment of the exclusive federal jurisdiction. This method of adopting a resolution to authorize the Governor to accept the federal jurisdiction over land in Nebraska has been used at least two times in the last ten years, including in 1971 when LR 53 which authorized the Governor to accept the retrocession of the Omaha Quartermaster Depot. I urge the acceptance of the resolution, LR 52.

PRESIDENT: Any further discussion on LR 52? Hearing none, Speaker Marvel, would you wish to close on the resolution?

SPEAKER MARVEL: I think it has been covered fairly well so I waive closing.

PRESIDENT: All right, closing is waived. The question is the adoption of LR 52. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 34 ayes, 0 nays on adoption of LR 52, Mr. President.

PRESIDENT: Motion carries. LR 52 is adopted. We will go then to LR 53, Mr. Clerk.

CLERK: Mr. President, LR 53. (Read) The resolution, Mr. President, is found on page 1330 of the Journal.

PRESIDENT: The Chair recognizes Senator Stoney.

SENATOR STONEY: Mr. President, members of the Legislature, the resolution speaks for itself. It recognizes and acknowledges the positive contribution that the secretaries have made to the nation and it proclaims the week of April 19th to the 25th, the Professional Secretaries Week, and Wednesday,

CLERK: Mr. President, LR 54. (Read) It is found on page 1376. It is offered by Senator Labedz.

PRESIDENT: The Chair recognizes Senator Labedz.

SENATOR LABEDZ: Thank you very much, Mr. President. Hymie Zorinsky was a personal friend of mine for many years because of my acquaintance, of course, with his son, Senator Edward Zorinsky, and the article that appeared in the World Herald gave most of his life's history but I wanted to reiterate some of the remarks. Zorinsky immigrated from his native Russia to the United States in 1924 and landing in Omaha. But before he did that, I might add that he found an organization that smuggled him into Poland because for many years he was trying to leave Russia and he lived in Poland and my family and friends of South Omaha were amazed at the fact that he could speak Polish so well and we enjoyed him very, very much and I know that Senator Zorinsky will certainly appreciate the fact that we have sent him this resolution and I appreciate everyone that signed it. Thank you so much.

PRESIDENT: Any further discussion on LR 54? Hearing none, Senator Labedz, I guess that will be your opening and closing. The question before the House is the adoption of LR 54. All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: 36 ayes, 0 nays on adoption of the resolution, Mr. President.

PRESIDENT: Motion carries and LR 54 is adopted. The next resolution under agenda item #4 is LR 55, Mr. Clerk.
