LB 389, 318, 440

an economical way to do what we need to be doing to allow someone else to work within that individual's abilities. Sometimes we need one kind of assistance and sometimes we need another but this will allow persons to be partially self-supporting and taxpayers at the same time. I urge your support for LB 389.

SENATOR V. JOHNSON: Thank you. Senator Wesely, do you have any further comments? The question is, shall LB 389 advance to E & R initial. All in favor signify by voting green, opposed vote red. Are there any others wishing to vote on the issue? Yes, it is to advance the bill, Senator Goodrich.

CLERK: Senator Johnson voting aye.

SENATOR V. JOHNSON: Record, Mr. Clerk.

CLERK: 26 ayes, 7 nays, Mr President, on the motion to advance the bill.

SENATOR V. JOHNSON: LB 389 is advanced.

CLERK: Mr. President, if I may read a couple of items. Senator Maresh would like to print amendments to LB 389. Mr. President, Senator Wiitala would like to print amendments to LB 440 and Senator Lamb to LB 318. (See pages 1471-1473 of the Legislative Journal.)

CLERK: Mr. President, LR 59 found on page 1472 of the Journal offered by Senators Maresh and Sieck. (Read.)

PRESIDENT: The Chair recognizes Senator Maresh.

SENATOR MARESH: Mr. President, members of the Legislature, not too long ago there was an article in the paper where this program was going on in Seward County. I thought it was really commendable to have a group look into this problem that we have in Nebraska where 13 million gallons of oil is used and much of it is disposed of by oiling driveways and dumping it out in the open and contaminating our water supply, our streams and harming our wildlife and so I think it is good that a group has come up with a solution for this by recycling this oil. A number of years ago I found that there was an oil filter that was manufactured in Lincoln, their own oil filter. At that time they said that you never had to change oil in your car. All you had to do was just change the element. I have wondered many times since why are we wasting all this oil if this was the case probably thirty-five years ago and nothing has been done. So there must be a system that this used oil can be recycled to take the impurities out of it and use it again as engine oil, and as the resolution states, it can be used as fuel in our furnaces and even our tractors and other uses. So I think we should commend these people for coming up with this solution to a grave problem so I would like to share with Senator Sieck. Because it is taking place in his district. I would like to have him speak about this program that is going on in his district.

PRESIDENT: The Chair recognizes Senator Sieck.

SENATOR SIECK: Mr. President, members of the body, I am proud to be a member of the Isaac Walton League that initiated this program in Seward County. The President of the Isaac Walton League at Seward is Max Farney who is very active in the Isaac program up there. We have had a

recycling program for many, many years as far as paper. glass and cans, aluminum cans and this has been going on for years and years and it is working. The Isaac, they volunteer to go up there and help every Saturday to package the papers, the cans and break the bottles and then deliver them. There is a trucking firm that puts its large semi up there and just left it set for us to load it up. The same thing is going to happen with the oil. We are going to be able to have someone come up there to pick up the oil. They are starting out with a fifty gallon barrel. I am sure they are going to have to have a lot more barrels because on my own place I have about twenty-five or fifty gallons of used oil that I don't know what to do with. used to be dumping it and I noticed in times past when I had a contractor out there doing some work he drained his oil. It took many years before any plant grew back where the oil was dumped and we had a new road put on our area and the county dumped their oil on the roadside. You can still see that spot where the oil was dumped. There is no grass or anything grows. So I am real pleased that the county is incorporating with the Isaac Walton League in initiating this program and I want to give regards to the Southeast Action Group to initiate this program and I think it is an excellent program and I highly endorse it. you.

PRESIDENT: Any further discussion on LR 59? Senator Maresh, do you have any closing?

SENATOR MARESH: I think we should send a copy of this resolution to all people involved, Southeast Nebraska Small Farms Action Group, the Isaac Walton League, Seward County Recycling Center and the Seward County Board. I think they all should receive a copy of this and I think they are doing a great job and we should compliment them for that. I move that the resolution be adopted.

PRESIDENT: The motion before the House then is the adoption of LR 59. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 34 ayes, 0 nays, Mr. President, on adoption of the resolution.
