Mr. President, a communication from the Governor addressed to the Clerk. (Re: LB 58, 283, and 491. See Legislative Journal, page 1594.)

Mr. President, a new resolution offered by Senator Wesely. (Read LR 64. See pages 1596 and 1597, Legislative Journal.) That will be laid over, Mr. President.

Mr. President, Senators Fowler and DeCamp ask unanimous consent to add their names to LB 180 as cointroducers.

SPEAKER MARVEL: Hearing no objection, so ordered.

CLERK: That is all that I have at this time, Mr. President.

SPEAKER MARVEL: I would like to recognize Senator Vickers for an announcement and then we will go to LB 499 which will be the last bill for the afternoon. Senator Vickers.

SENATOR VICKERS: Mr. President, thank you very much. Mr. President and members, on your desks this morning you found a little page with the schedule of events for Heritage Days to be held at McCook, Nebraska, May the 1st, May the 2nd and May the 3rd, and along with that schedule, I am issuing to you an invitation from the McCook Chamber of Commerce to any and all of you that are able to be there on Saturday, May the 2nd for their parade at tenthirty and they would like to have you there a little bit ahead of time and vehicles will be provided for anybody that ... any of the members that were able to be there and also the luncheon put on by the Cordials, the ladies group of the Chamber of Commerce, and I might add it will be a very enjoyable luncheon, I am sure. As you notice, there is a variety of ethnic foods will be available, and also, of course, it is out in the middle of the 38th District and I would be happy and proud to be your host to any and all that could make it. SPEAKER MARVEL: Thank you, sir. Okay, we are now ready to go to LB 499.

CLERK: Mr. President, LB 499 (read title). The bill was first read on January 20, referred to Public Health and Welfare. The bill was advanced to General File. There are committee amendments pending by Public Health and Welfare Committee, Mr. President.

CLERK: Mr. President, .E. 44, offered by Senators Wesely and Newell.

PRESIDENT: Is either Jenator Wesely or Senator Newell present? I don't see them, Wr. Clerk. The Chair recornizes Senator Fowler.

SENATOR FOWLER: Mr. President, I move that we kill the resolution since they are not here.

PRESIDENT: If you will put that in writing and on the desk we will take it up immediately. We also have the next motion of Senator Newell's sc... Here comes Senator Wesely. Senator Wesely, we are ready with LR 64. There was an oral motion to kill, not to indefinitely postpone it, just to kill it so, Mr. Clerk, will you read the resolution so that Senator Wesely can gather his...can settle jown after hearing that.

ASSISTANT CLERK: Mr. President, LR 64 was introduced by Senator Don Wesely and Senator Dave Newell. (Read.)

PRESIDENT: All right, the Chair recognizes Senator Wesely.

SENATOR WESELY: Mr. President, members of the Legislature, this resolution was cosponsored by Senator Newell and myself and I am sure that kill motion was in jest because I realize there was a similar resolution that was introduced by myself alone and that was killed although it did go through a conmittee hearing and was advanced by the committee and had a Freat deal of support. However, there were some concerns about these revenue bonds and the problems that they created and the tax exempt status and so there was a great deal of concern that was expressed and the decision not to support the resolution last time. So the decision was to out out all the different verbage about the tax exempt bonds being able to do different activities and all the great things about that and set down to the one nub of the problem and that was a problem that we have with Nebraska having a mortgage finance fund that just started a couple of years ago and thus, has not built up a reserve and thus a turnover that can then be used to support the actual management of that fund and whether or not you like mortgage fin-ance funds or whether or not you like revenue bonds and tax exempt bonds is not really the question at this point. The question is that Congress has claced restrictions on the different states' programs like this and the one restriction that really hurts Netraska more than any other state

and really does not affect most other states because they have been around a lot longer is this 1% arbitrage figure. And what that essentially means is that they issue the bonds Then they can only let out loans at 11% and say at 10%. thus have a 1% margin in which to operate the fund to provide incentive to the banker or the savings and loan to issue the loans and those sort of things and I guess the problem is basically this. They cannot administer the fund with that sort of a restriction. It is simply too much of a burden because we are a new fund and it is not working properly in regards to the fact that it is so new and so it seems to me that we can place restrictions and we can talk all we want to about shutting down these different activities that have been abused but this is a separate case. This is talking about just administering what we now have. It doesn't add anything or take away from the situation but just says the mortgage finance fund in order to operate what we already have has got to have this arbitrage figure changed and that is all we are saying in this resolution. We are not changing anything else. We are not anying 1. 1. good or bud or anything about it but we are saying that we have got a fund, it is sponting, it cannot continue to operate without a change in that applicate fire ure and we have not a congressional deteration back there that is quite willing to take the lead on this but they would like to have a resolution from the Legislature saying that this is important to us and that is why again, we came in and, again Senator Newell and I sat down. Senator Newell opposed the resolution that we had originally introduced several weeks ago and after we talked to him about it he understood better the situation and I hope that you do now too, that we are talking about one primary problem. We are not talking about going back to the place where we started with this whole thing. We are just talking about taking care of the one problem that has really caused a headache for the mortgage finance fund, has basically stifled the situation and until that is changed we are in trouble with it. So, that is the resolution. That is the change. T am sorry Senator Newell is not here to express why he has changed his mind and is supporting this resolution but let me tell you that it is a very important resolution to the State of Nebraska and the mortgage finance fund.

PRESIDENT: Any further discussion on LR 64? Hearing none, Senator Wesely, I guess that is your opening and your closing unless you have another remark. The motion then is the adoption of LR 64. All those in favor vote aye, opposed nay. Have you all voted? Senator Wesely, what do you wish to do?

SENATOR WESELY: I know my speech enthralled them. They are

CLERK: (Read roll call vote as found on pages 1741-1742 of the Legislative Journal.) 26 ayes, ll nays, Mr. President, on adoption of the resolution.

PRESIDENT: The motion carries. LR 64 is adopted. Before we proceed the Chair would like to introduce some nineteen students from Farwell, Nebraska, with Mrs. Earl Lincoln, their teacher. They are from Senator Wagner's district and they are up in the north balcony. We welcome the Farwell students and Mrs. Lincoln to your Unicameral Legislature. Welcome. We are ready for agenda item #5.

CLERK: Mr. President, Senator Newell moves to withdraw LB 555.

PRESIDENT: Senator Newell, we are ready for your withdrawal motion on LB 555.

SENATOR NEWELL: Mr. President, members of the body, LB 555 is the Falstaff resolution of the anything of value question which is passed already. The bill is not necessary and I would urge the body to withdraw it.

PRESIDENT: Is that it, Senator Newell? Any further discussion then on Senator Newell's motion to withdraw? All those in favor then of withdrawing LB 555 vote aye, opposed nay. Have you all voted? Record the vote.

PRESIDENT: While the Legislature is in session and capable of doing business, I propose to sign and do sign LBs 35, 76 and LR 64. CLERK: Read LR 75.
